## WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

Consideration of a proposed agenda for the September 27, 2016 Damascus summit.

### **EXECUTIVE SUMMARY:**

With the disincorporation of the City of Damascus, Clackamas County has assumed land use jurisdiction of around 10,000 acres of unincorporated area inside the Urban Growth Boundary. The future of the area will involve various government partners. The City of Happy Valley has begun to annex portions of the western area of the former City. Metro has mentioned removing areas in the east from the Urban Growth Boundary and using the land to land bank or trade land into the UGB in other areas in and out of Clackamas County. The City of Gresham is also a possible urban service provider for portions of the area. Of course, the most important people are the residents, businesses and property owners in the former city.

Given the number of potential players involved, and that fact that uncoordinated conversations are already happening, it makes sense to begin a joint discussion on how to work together, involve our citizens and create a successful place.
