Approval of an Agreement with Volunteers of America Oregon for Outpatient Substance Abuse Treatment Services

The Clackamas County Behavioral Health Division of the Health, Housing & Human Services Department requests the approval of a Behavioral Health Services Agreement with Volunteers of America Oregon for outpatient substance abuse treatment services. The contractor will provide addiction treatment services to Latinos in Clackamas County through their Adelante program.

This is a no maximum agreement. Expenditures are controlled by Clackamas Mental Health Organization staff that pre-authorize and monitor services on an ongoing basis.

The agreement is funded with State of Oregon General Funds. No County General Funds are involved. County Counsel has reviewed and approved this contract as part of the H3S contract standardization project. It is effective upon signature and terminates on December 31, 2011.

We recommend the approval of this agreement and that Cindy Becker be authorized to sign on behalf of the Board of County Commissioners.

Consent for Acquisition of the Parent Company of American Medical Response, Emergency Medical Services Corporation, by Affiliates of Clayton, Dubilier & Rice, LLC

Clackamas County Health, Housing and Human Services Department requests the consent of the Board of County Commissioners for the acquisition of Emergency Medical Services Corporation by affiliates of Clayton, Dubilier & Rice, LLC.

American Medical Response, Inc., which provides ambulance and emergency medical services in a portion of Clackamas County pursuant to an exclusive franchise, has notified the County of a proposed transaction where its parent company, Emergency Medical Services Corporation (EMSC), will be acquired by affiliates of Clayton, Dubilier & Rice, LLC (CD&R), a private equity company. When the transactions are completed, EMSC will be a wholly-owned subsidiary of an affiliate of CD&R and will no longer be a publicly traded company. American Medical Response, Inc. is requesting the consent of the Clackamas County Board of County Commissioners for this transaction as called for in the Ambulance Services Contract.

This will not change the name or tax identification number of American Medical Response, Inc., and security commitments, including performance bonds and insurance, will remain intact and unchanged by the merger.

The consent of the Clackamas County Board of County Commissioners to this transfer does not constitute a waiver or release of any of the rights of the County under this contract.

Recommendation

We recommend consent be granted for this merger and that Cindy Becker be authorized to sign on behalf of the Board of County Commissioners.

Approval of Amendment #8 to the Contract with SERA Architects Inc. for Architectural, Interiors and Engineering Services for the Renovation of the Clackamas County Sunnybrook Building and the Design of the New Evidence Processing and Crime Lab

In early 2009, the County and SERA Architects Inc. conducted a Facilities Master Planning effort concentrating on the needs of the County Sheriff's operations in the County with emphasis on Jail improvements and the potential reuse of the Sunnybrook facility by the Sheriff's Office. The review determined that the Sunnybrook Building could provide a consolidated site, housing the Sheriff's Office and the new Justice Court operations. The planning effort also determined that a new Evidence Processing and Crime Lab with expansion room for the future would enhance the day to day operation of the Sheriff's Office.

During the course of the project, refinements to the initial scope of work became necessary. Amendment #8 (\$36,510.00) provides assistance with BETC and Energy Trust credits and PGE net metering programs, additional design work to address latent building conditions discovered during the renovation effort, owner requested changes in scope, and extension of project duration.

Funds for this contract are budgeted under 420-0221-00-431000-76076. The total amount of the amended contract is not to exceed \$1,830,041.55. Amendment #8 has been reviewed and approved by County Counsel.

RECOMMENDATION:

Staff respectfully recommends that the Board approve Amendment #8 to the contract with SERA Architects Inc. for Architectural, Interiors and Engineering Services for the Renovation of the Clackamas County Sunnybrook Building and the Design of the new Evidence Processing and Crime Lab.

Cooperative Intergovernmental Agreement between Clackamas County and the City of Gladstone for Capital Contribution

Attached please find an Intergovernmental Agreement, (IGA) between Clackamas County and the City of Gladstone.

Concurrent with and conditional on the Clackamas County Library District ("Library District") formation effort, the Board of County Commissioners ("Board") agreed to provide capital funds to City library service providers over the next 5 fiscal years to help address capital needs in their service areas and provide better service to unincorporated areas. These capital funds are to be drawn from operational funds previously distributed from the county general fund to Cities for library services that will now be supplied by the Library District.

The County currently funds the Library Network, an informational and administrative service that allows the various libraries in the County to operate cooperatively and gain efficiencies. The Library District is not intended to fund the Library Network. A related commitment from the Board as part of the formation process was to fund the Library Network at its current service level into the future. In an effort to have the cities provide library services and the Library District provide operational funds support, the County will transfer County Library operations of the Oak Lodge Library to the City of Gladstone, fall 2012..

This intergovernmental agreement addresses (1) the provision of capital funds to each City service provider, (2) the County's commitment to fund the Library Network, and (3) the issues related to the transfer of County Library operations of the Oak Lodge Library to the City of Gladstone, once the new library in Gladstone is built, and the two facilities merge. County Counsel has reviewed and approved this IGA.

RECOMMENDATION:

Business and Community Services_respectfully recommends that the Board of Clackamas County Commissioners approve and sign the attached IGA between Clackamas County and the City of Gladstone.

AMENDMENT No. 1
TO THE AGREEMENT TO FURNISH CONSULTANT SERVICES TO
CLACKAMAS COUNTY SERVICE DISTRICT NO. 1 FOR
ENVIRONMENTAL ENGINEERING, STORM WATER, AND SURFACE WATER
MANAGEMENT SERVICES

On May 14, 2009 Clackamas County Service District No. 1 (CCSD#1) entered into an On-Call contract with Brown and Caldwell, Inc. to provide environmental engineering professional services on a continuing basis for assistance for a one year period, with the option of three additional one year extensions.

Staff has identified additional services needed that were not covered in the original Agreement:

- Develop a Surface Water Management Program Review and Reporting Tool for evaluating and reporting on the overall program progress on a yearly basis. The tool will serve the dual purposes of reporting progress to external audiences as well as internal staff to evaluate program progress. Cost \$25,842.00
- Develop a Comprehensive Monitoring Plan to resolve outstanding issues with respect to the development of the Clackamas County Comprehensive Monitoring Plan for submittal to DEQ by June 15, 2011. Cost: \$11,200

District staff has negotiated Amendment 1 with Brown and Caldwell, Inc. for an amount not to exceed \$37,042.00, bringing the total for the contract to \$288,540.00.

If approved, the additional work will be funded by the CCSD#1 Surface Water Management Operating Budget. District counsel has reviewed the Amendment as to form.

APPROVAL OF AN INTER-GOVERNMENTAL AGREEMENT BETWEEN CLACKAMAS COUNTY SERVICE DISTRICT NO. 1 (CCSD#1), THE SURFACE WATER MANAGEMENT AGENCY OF CLACKAMAS COUNTY (SWMACC), AND THE OREGON DEPARTMENT OF ENVIRONMENTAL QUALITY (ODEQ) FOR ISSUANCE AND ADMINISTRATION OF STORMWATER DISCHARGE GENERAL 1200-CN PERMITS

In 1992, Clackamas County signed a Memorandum of Agreement (MOA) with ODEQ for the County to act as an Agent of DEQ in the issuance and administration of 1200-C permits (Stormwater Discharges during Construction). Water Environment Services (WES) was designated by the BCC as the County department responsible for implementing the agreement. In partnership with WES and multiple other jurisdictions, ODEQ has recently completed efforts to further streamline the 1200-C permitting process and reduce the overall permitting burden. The result was the creation of a new permit category called a 1200-CN. 1200-CN permits are available to be automatically granted to those projects that disturb less than 5 acres within a jurisdiction that has a DEQ approved Erosion Prevention and Sediment Control Program. No additional applications, forms or fees will be needed beyond those required by the local jurisdiction's program. As the CCSD#1 and SWMACC programs have been approved by ODEQ under the CCSD#1 & SWMACC Phase I MS4 permits, WES is eligible to offer automatic extended coverage of the 1200-CN permits.

The attached IGA describes the agreement with ODEQ to streamline the permitting process for 1200-C permit activities within CCSD#1 and SWMACC. The Agreement may be terminated by either party with 30 days notice. There is no additional cost for the work. District Counsel has approved the Agreement as to form.

RECOMMENDATION

Staff respectfully recommends that the Board of County Commissioners approve the Intergovernmental Agreement between CCSD#1, SWMACC and ODEQ for issuance and administration of 1200-CN permits.
