If a ballot was sent to someone who is deceased, please write "DECEASED" on the envelope and place it back in your mailbox.


Instructions for Completing Your Ballot


Examine your Official Ballot

Locate the candidate or measure response (YES or NO) of your choice for each contest. To vote, you must completely darken the oval to the left of the response of your choice with pencil or black or blue ink pen.

To vote for a write-in candidate, one whose name does not appear on the Official Ballot, completely darken the oval to the left of the solid line provided for the office and write the full name of the candidate on that line.

Remember: If you vote for more than the number of candidates allowed for an office, or vote both YES and NO on a measure, it is called an overvote, and your vote for that office or measure will not be counted.






Review your Official Ballot

Ensure you have correctly marked your choice for each contest. Your Official Ballot may contain contests printed on both front and back. Remember to vote both sides!

If you make an error on your ballot, spoil it in any way or lose it, contact the Clackamas County Elections Division at 503.655.8510 (or for TTY, 503.655.1685) to request a replacement.



Return your Official Ballot

Place ONLY YOUR voted Official Ballot in the ballot secrecy envelope and seal the envelope.

Place the sealed secrecy envelope in the return identification envelope and seal it.

Remember: Read and sign the Voter's Statement on the return identification envelope. Your ballot will not be counted if the return identification envelope is not signed.



By mail:

■ Attach sufficient first-class postage to the **signed** and sealed return identification envelope. Mail it as soon as possible to arrive at the Clackamas County Elections Division no later than 8:00 p.m. on Tuesday, May 15, 2007.

Remember: the postmark does not count!

In person:

Deliver the signed and sealed return identification envelope to any official drop site (see list on Page 71) no later than 8:00 p.m. on Tuesday, May 15, 2007.

Postage is NOT required if delivered to an official ballot drop site!

MEASURE APPROVING ANNEXATION OF 32.62 ACRES INTO CITY OF CANBY

QUESTION: Shall 32.62 acres located at 23849 S Mulino Road, north of Township Road, be annexed into Carby?

SUMMARY: Annexation is the legal process to bring property into the City limits. The Parsons Family Trust has filed an application as the owners of a 32.62 acre parcel, asking the City to bring it into the Canby City limits. The legal description of the property is Tax Lots 2400 and 3100 of Tax Map 3-1E-34. The parcel is located at 23849 S. Mulino Road, north of Township Road, in Southeast Canby. This application has previously been approved by the City Council following a public hearing on February 7, 2007. The property currently contains a residence and several outbuildings. It is currently zoned Exclusive Farm Use (EFU) by Clackamas County. The City's Zoning Map designates the property for Light Industrial (M-1) zoning upon annexation. Any future development requires City review and must comply with land use laws

EXPLANATORY STATEMENT

This measure would approve the annexation of 32.62 acres into the city limits of the City of Canby. The property which would be included within the City boundaries is known as Tax Lots 2400 and 3100 of Tax Map 3-1E-34 and is located at 23849 S. Mulino Road, north of Township Road, in the southeast part of the City. Tax Lots 2400 and 3100 are currently zoned Exclusive Farm Use (EFU) under County zoning. If annexation into the City is approved by the voters, the parcels would be rezoned to M-1, Light Industrial, as required under the City's Comprehensive Land Use Plan (Comp Plan) and Zoning Map.

Tax Lots 2400 and 3100 are owned by the Parsons Family Trust. The Trust has filed an application for annexation into the City of Canby. The City, following its Charter, has put this matter before the voters for approval.

The parcel is located at 23849 S. Mulino Road, north of Township Road, in Southeast Canby. The property currently contains one single family residence and several outbuildings. Adjacent properties to the north and a portion of the properties to the west are within current city limits. Adjacent properties to the south and a portion of the properties to the west are located outside the current city limits. Properties to the east are located outside the City's Urban Growth Boundary. Properties to the north and west are zoned for Light Industrial development. Property to the south is outside the city limits, but is within Canby's Urban Growth Boundary and would be zoned Light Industrial upon annexation. The applicant proposes to market the property as Light Industrial as part of the Pioneer Industrial Park designation, Annexation alone does not set the future uses to be built on the property. Any further development would have to comply with state and local land use laws and would be subject to public review.

The Canby Comp Plan also designates properties for annexation as Priority "A", "B" or "C". Priority "A" properties shall generally be annexed prior to those areas shown as Priority "B" which, in turn, shall generally be annexed prior to those areas shown as Priority "C". The property is priority "C". The Canby Planning Commission unanimously voted to approve the application and the Canby City Council also unanimously voted to approve the application and refer it to a vote of the Canby electorate.

MEASURE APPROVING ANNEXATION OF 1.95 ACRES INTO CITY OF CANBY

QUESTION: Shall 1.95 acres located at 1401 S Fir Street be annexed into Canby?

SUMMARY: Annexation is the legal process to bring property into the City limits. Nick and Jamie Netter have filed an application on behalf of Todd and Theresa Snelson, the owners of a 1.95 acre parcel, asking the City to bring it into the Canby City limits. The legal description of the property is Tax Lot 1301 of Tax Map 4-1E-4CA. The parcel is located at 1401 S Fir Street in Canby. This application has previously been approved by the City Council following a public hearing on February 7, 2007. The property currently contains one single family residence and three outbuildings. It is currently zoned Exclusive Farm Use (EFU) by Clackamas County. The City's Zoning Map designates the property for Medium Density Residential (R-1.5) zoning upon annexation. Any future development requires City review and must comply with land use laws.

EXPLANATORY STATEMENT

This measure would approve the annexation of 1.95 acres into the city limits of the City of Canby. The property which would be included within the City boundaries is known as Tax Lot 1301 of Tax Map 4-1E-4CA and is located generally in the southwest part of the City. Tax Lot 1301 is currently zoned Exclusive Farm Use (EFU) under County zoning. If annexation into the City is approved by the voters, the parcel would be rezoned to R-1.5, Medium Density Residential, as required under the City's Comprehensive Land Use Plan (Comp Plan) and Zoning Map.

Tax Lot 1301 is owned by Todd and Theresa Snelson. Nick and Jamie Netter have filed an application, on behalf of the Snelsons, for annexation into the City of Canby. The City, following its Charter, has put this matter before the voters for approval.


The parcel is located at 1401 S Fir Street, south of SW 13th Avenue, near Hope Village. The property currently contains one single family residence and three outbuildings. Adjacent properties to the north, west and east are within current city limits. Adjacent properties to the south are located outside the current city limits. Properties to the north (Sequoia Place) and east (Hope Village) are zoned for Medium Density Residential. Property to the west is zoned Low Density Residential, while property to the south is outside the city limits, it is within Canby's Urban Growth Boundary and would be zoned Medium Density Residential upon annexation. Under the R-1.5 zoning regulations, the applicant proposes to construct 12 single family residences. Annexation alone does not set the future uses to be built on the property. Any further development would have to comply with state and local land use laws and would be subject to public review.

The Canby Comp Plan also designates properties for annexation as Priority "A", "B" or "C". Priority "A" properties shall generally be annexed prior to those areas shown as Priority "B" which, in turn, shall generally be annexed prior to those areas shown as Priority "C". The property is priority "A". The Canby Planning Commission unanimously voted to approve the application and the Canby City Council unanimously voted to approve the application and refer it to a vote of the Canby electorate.



ANNEXATION OF 10 ACRES INTO THE ESTACADA CITY LIMITS

QUESTION: Shall 10 acres located east of the Coupland Road/Cemetery Road intersection be annexed into the City of Estacada?

SUMMARY: Approval of this measure would bring into the Estacada city limits 10 acres located approximately 600' off the north side of Coupland Road, approximately 1/4 mile east of the Coupland Road/Cemetery Road intersection. This annexation was requested by landowner petition.

Property to be annexed must touch existing city limits, and there must be adequate city services such as schools, water, and roads to serve the property. The Estacada City Council has determined that these requirements are met, and submits the question of annexation of the territory to the voters as required by the Estacada City Charter. If annexed, the described property will become subject to the City's permanent property tax rate limit and will be eligible to receive services from the City.

EXPLANATORY STATEMENT

This ballot measure is a proposed annexation measure being submitted to the voters of the City of Estacada at this election.

Annexation is the procedure used to add land to the corporate boundaries of a city. Approval of an annexation measure will bring that property within the City limits. Once the land is annexed, the annexed territory is subject to the City's permanent property tax rate, and becomes eligible to receive city services.

As required by the Estacada City Charter, the City Council must submit to the voters any proposals for annexation of territory into the City. It is proposed that the following property be annexed to the City:

10 acres located approximately 600' off the north side of Coupland Road, approximately 1/4 miles east of the Coupland Road/Cemetery Road intersection.

This annexation was requested by landowner petition. The Estacada City Council has determined that the petition meets the City Code requirements for annexation. This property is within the City's urban growth boundary and is contiguous to property already within the City limits. Clackamas County currently zones the property RRFF-5. If annexed into the city, the property will be zoned R-I, Low Density Residential, in accordance with the City Comprehensive Plan.

REGISTERING TO VOTE

[SOME FREQUENTLY-ASKED QUESTIONS]

WHO MAY REGISTER TO VOTE?

Anyone who is:

- * A resident of Oregon;
- * A United States citizen; and
- ★ 18 years of age or older.

HOW MAY I REGISTER?

By mail-in registration form or in person at any county elections office or at a designated state agency, including the Department of Motor Vehicles and some public assistance agencies.

WHEN MAY I REGISTER & WHAT IS THE REGISTRATION DEADLINE?

You may register at any time. However, your voter registration form must be received or postmarked no later than the 21st day before the election at which you intend to vote.

WHERE CAN I FIND VOTER REGISTRATION FORMS?

Post offices, public libraries, city halls, schools, the DMV, and Clackamas County Elections, 825 Portland Avenue in Gladstone. You can download and print a form in PDF format from the Secretary of State's web site at the Oregon Voter Registration link, which can be found at http://www.oregonvotes.org

WHAT INFORMATION IS REQUIRED?

In October 2002, the "Help America Vote Act" was signed into law. The Act changes voter registration requirements nationwide for voting in federal elections. If you are registering to vote in Oregon for the first time, you must provide an Oregon Driver's License / ID. If you do not have a valid ODL / ID, the last four digits of your Social Security number must be provided.

If you do not have a valid Oregon Driver's License / ID or a Social Security number, you must affirm this by marking the appropriate box on the registration form. If you are registering by mail, you must provide a **copy** of one of the following: a valid photo identification, a copy of a paycheck stub, utility bill, bank statement or other government document showing the registrant's name and address.


If sufficient documentation is not provided at the time of registration, it will be requested by elections officials in order for the person to vote at the next federal election. When filling out the registration card, you must furnish your full name, residence address (and mailing address, if different), ODL or Oregon ID, date of birth, political party preference, and signature. Your residence address must be the physical address where you reside - not a post office box.

DO I HAVE TO RE-REGISTER FOR EACH ELECTION?

No. You only need to update your registration when your residence (even moving to a different apartment within a complex) or mailing address changes; your name changes; or you wish to change your political party affiliation.

WHAT IF I TURN 18 AFTER THE REGISTRATION DEADLINE?

If you will be 18 years of age by election day, you must register no later than the 21st day prior to the election to be eligible to vote in that election.

QUESTION: Shall the City's boundaries include 27 acres of additional land on the south central edge of the City?

SUMMARY: A 27-acre set of parcels comprised of twentyseven (27) tax lots located on Thayer, Beavercreek and Maplelane Roads. Some properties are being forced by the "double majority" rule to annex. The proposal was submitted to allow connection to city services for existing and future homes. The property contains 22 dwellings with 35 residents, currently zoned FU-10 "Future Urbanizable", and located within the City's UGB. The County's "Oregon City Area Land Use Plan" designates the property Low Density Residential. The City Commission has concluded that it meets all state. regional and City requirements for annexation into the City and services can be adequately provided to the property. If this annexation is approved, the properties will be withdrawn from the Clackamas County's Service District for Enhanced Law Enforcement and Fire District #1 and the City will be responsible for police and fire services.

EXPLANATORY STATEMENT

This measure would expand the City's boundaries by approximately 27 acres by including within the City property described as follows:

A 27-acre set of parcels comprised of twenty-seven (27) tax lots located on Thayer, Beavercreek and Maplelane Roads consisting of Tax Lots 300-302, 400, 600-601, and 700-1400 (by 100) in the SW 1/4 of SE 1/4 of Section 4 (4DC); Tax Lot 3300 in the SE 1/4 of SW 1/4 of Section 4 (4CD); and Tax Lots 500, 501, 600, 700, 800, 1000, 1301, 1400-1401, 1601-1602, 1700, 1801, and 1900 in the NW 1/4 of NE 1/4 of Section 9 (9AB); T3S R2E; W.M., Clackamas County, Oregon. Some properties are being forced by the "double majority" rule to annex.

The proposal was submitted to allow connection to city services for existing and future homes. The property contains 22 dwellings with 35 residents, currently zoned FU-10 "Future Urbanizable", and located within the City's UGB. The County's "Oregon City Area Land Use Plan" designates the property Low Density Residential. If this annexation is approved, the properties will be withdrawn from the Clackamas County's Service District for Enhanced Law Enforcement and Fire District #1 and the City will be responsible for police and fire services.

EXPLANATORY STATEMENT

This measure would expand the City's boundaries by approximately 16 acres by including within the City property described as follows:

A 16-acre set of parcels comprised of eight (8) tax lots located in the south central side of the City on both sides of Pease Road and on one side of McCord Road consisting of Tax Lot 1700, in the SW 1/4 of NE 1/4 of Section 7 (7AC); Tax Lot 6700 in the NE 1/4 of NW 1/4 of Section 7 (7BA); and Tax Lots 3600, 3601, 3602, 3700, 3800, and 3900 in the NW 1/4 of Section 7 (7B); T3S R2E; W.M., Clackamas County, Oregon.

The proposal was submitted to allow connection to city services for existing and future homes. The property contains 5 dwellings wiith 11 residents, currently zoned FU-10 "Future Urbanizable", and located within the City's UGB. The County's "Oregon City Area Land Use Plan" designates the property Low Density Residential. The City Commission has concluded that it meets all state, regional and City requirements for annexation into the City and services can be adequately provided to the property.

If this annexation is approved, the properties will be withdrawn from the Clackamas County's Service District for Enhanced Law Enforcement and Fire District #1 and the Clty will be responsible for police and fire services.

The City Charter requires voter approval of all annexations. A map showing the parcels accompanies this explanatory statement.



AMENDS CHARTER: REQUIRES CITY TO PERIODICALLY REVIEW CHARTER

QUESTION: Shall Council convene Charter Review Commission at least every 10 years with recommendations submitted to voters in certain circumstances?

SUMMARY: Currently there is no requirement for periodic review of the City Charter. This measure requires the Council to convene a Charter Review Commission at least every 10 years. The first Commission will convene within two years after the effective date of this measure. The Commission will reflect the diversity of the City and will be made up of 20 residents. Each Council member shall nominate four Charter Commission members, subject to confirmation by the Council. The Mayor and Council can request review of specific Charter sections, but the Commission's review is not limited to such sections. The Commission must provide written reports to the Council. Charter amendments supported by at least 15 members of the Charter Commission shall be submitted to the voters of the City by the City Council. Charter amendments proposed by the Charter Commission that are supported by a majority but less than 15 members of the Charter Commission shall be recommendations to the City Council, which may, but is not required to refer such proposed amendments to the voters.

EXPLANATORY STATEMENT

This measure is one of four recommendations by the 26 citizenmember Charter Review Commission.

It requires the City Council to convene a panel of citizens at least once every 10 years to review the City Charter and forward their recommendations directly to voters.

Background

In November 2005, Portland City Council appointed a panel of 26 Portlanders to take the first comprehensive look at the City Charter since 1913. This independent volunteer citizen committee – the Charter Review Commission – represented a wide range of ages, ethnicities, experiences and backgrounds.

To facilitate its work, the Commission held over 100 public meetings, collected information from a variety of sources, including review of written reports, invited testimony from legal and academic experts, and public testimony, including:

- Testimony from current and former elected officials of Portland and other municipalities, City employees, community organizations, neighborhood associations and other stakeholder groups and individuals;
- Testimony of outside experts in government studies and public administration; and
- · A survey of comparably-sized cities.

What does the measure do?

Currently, the City Council decides when, or if, citizens can review the Charter, the document that spells out the laws and procedures that define how the city operates. Under the current system any changes proposed by citizens must be approved by the City Council and then referred to voters.

The measure:

Provides more citizen oversight by requiring the City Council
to convene a panel of no more than 20 citizens who are
representative of the entire city to review the Charter at
least every ten years.

 Establishes a process that allows the citizen commission to put recommendations directly before voters without City Council approval.

Elected officials would be excluded from being members of the Charter Commission. And, while the City Council can request the review of specific Charter sections, the Commission would be free to review any part of the Charter it chooses.

Each Council member would nominate four Charter Commission members, subject to confirmation by the entire Council. Charter amendments supported by at least 15 members of the Charter Commission would be submitted directly to the voters.

The Portland Metro area is expected to grow by 1 million residents in the next few decades. The Charter Review Commission recommended periodic review in order to permit citizens to periodically determine whether the City's governance reflected the changing needs of the city and its residents. The Commission also said that periodic review would continue Portland's tradition of civic engagement and citizen involvement in the workings of their government.

The first review would take place within two years of the passage of this measure.

AMENDS CHARTER: UPDATES AND CLARIFIES CIVIL SERVICE PROVISIONS

QUESTION: Shall City simplify civil service provisions, authorize Council to implement merit system, exclude certain policy-making employees from civil service?

SUMMARY: This measure maintains the City's Civil Service Board that is appointed by the Mayor and confirmed by the City Council. The measure clarifies the merit system for civil service protected positions by replacing existing provisions with updated language and giving City Council power to establish, regulate and maintain the merit system and designate protected categories of persons. Details of implementation relating to job classification plans, recruitment, selection and promotions are removed from the Charter, allowing the Council more flexibility in implementing the meritbased system. The measure establishes a 21 day period for appeals to the Civil Service Board. The measure removes current provisions for temporary appointments.

The measure allows the Council, upon recommendation of the administrator for personnel issues, to determine that future employees in a classification with a major role in the formation of policy requiring exercise of Independent judgment will be excluded from civil service protection. This measure will become effective January 1, 2008.

EXPLANATORY STATEMENT

This measure is one of four recommendations by the 26 citizenmember Charter Review Commission.

It streamlines and modernizes the City's civil service requirements by eliminating outdated, conflicting and confusing language.

Background

In November 2005, Portland City Council appointed a panel of 26 Portlanders to take the first comprehensive look at the City Charter since 1913. This independent volunteer citizen committee - the Charter Review Commission - represented a wide range of ages, ethnicities, experiences and backgrounds.

To facilitate its work, the Commission held over 100 public meetings, collected information from a variety of sources including review of written reports, invited testimony from legal and academic experts, and public testimony, including:

- Testimony from current and former elected officials of Portland and other municipalities, City employees, community organizations, neighborhood associations and other stakeholder groups and individuals;
- Testimony of outside experts in government studies and public administration; and
- A survey of comparably-sized cities.

What does the measure do?

After 14 months of study the Charter Review Commission found the civil service requirements confusing, conflicting, and outdated. The most recent amendments to some of these civil service requirements were nearly twenty years ago.

The measure:

- · Deletes or updates outdated language;
- Requires an annual report to City Council from the Civil Service Board:

- Requires the Civil Service Board to meet at least quar-
- Provides a more flexible and adaptable structure for a merit based personnel system;
- Standardizes the civil service appeals process; and
- Allows for certain top level employees to be removed based on non-performance. This only applies to certain future employees.

The measure provides the City workforce with more current, consistent, and predictable civil service requirements and protections.

If passed, the measure will become effective January 1, 2008.

AMENDS CHARTER: CHANGES FORM OF CITY GOVERNMENT

QUESTION: Shall executive authority be transferred from Commissioners to the Mayor, and Council exercise legislative and quasi-judicial duties?

SUMMARY: The measure changes the structure of city government adopted in 1913. City Council members and Mayor currently share all executive, legislative, quasi-judicial and administrative functions. This measure distributes executive and administrative functions to Mayor and legislative and quasi-judicial functions to Council. The Mayor remains a voting member of Council, but does not have veto power. The Mayor prepares the budget, distributes work among offices, hires and discharges most employees, subject to civil service. Council adopts the budget and strategic plans, and exercises legislative oversight through investigations and hearings.

The measure authorizes Chief Administrative Officer (CAO) to manage and coordinate city operations, administration and personnel, under supervision of the Mayor. The Mayor hires the CAO, subject to Council confirmation. The Mayor may fire the CAO.

Bureau directors are currently hired by individual Commissioners. The measure transfers responsibility for performance, including hiring and firing of bureau directors, to the Mayor.

The measure also changes the process for filling vacancies in City elective office. This measure is effective January 1, 2009.

EXPLANATORY STATEMENT

This measure is one of four recommendations by the 26 citizenmember Charter Review Commission.

The measure increases coordination of City services by centralizing City management in the chief administrative officer.

Background

In November 2005, Portland City Council appointed a panel of 26 Portlanders to take the first comprehensive look at the City Charter since 1913. This independent volunteer citizen committee – the Charter Review Commission – represented a wide range of ages, ethnicities, experiences and backgrounds.

To facilitate its work, the Commission held over 100 public meetings, collected information from a variety of sources, including review of written reports, invited testimony from legal and academic experts, and public testimony, including:

- Testimony from current and former elected officials of Portland and other municipalities, city employees, community organizations, neighborhood associations and other stakeholder groups and individuals;
- Testimony from outside experts in government studies and public administration; and
- · A survey of comparably-sized cities.

What does the measure do?

Portland's current form of government was adopted in 1913. This 'commission' form of government combines the legislative and executive functions together in a five member commission. It requires that specific administrative responsibilities be divided among five elected City Commissioners, or City Council members, in addition to traditional legislative and oversight responsibilities.

sibilities. When elected, City Council members assume full time administrative roles as department heads of City bureaus.

The measure:

- Directs the Mayor, subject to City Council approval, to appoint a chief administrative officer to oversee the delivery and coordination of all City services and bureaus.
- Directs the City Council to oversee the budget, set strategic direction and policies, exercise oversight of City operations through investigations, committees and hearings, and provide constituent representation.
- Directs the City Council to retain legislative and quasi-judicial authority.
- Maintains a City Attorney appointed and removed by the City Council.
- Retains the Mayor as a voting member of the five member Council.
- Does not provide the Mayor veto authority over Council actions.
- Requires appointments of all bureau directors be approved by the City Council.
- Requires all appointments made by the Mayor be approved by the City Council.
- · Maintains an independently elected Auditor and staff.

This measure replaces the current form of government where City Council decides public policy and administers City bureaus. It replaces the current form of government with a governing structure where the mayor is held accountable for a chief administrative officer who runs the day to day operation of the City and City Council members focus on setting policy, approving budgets, exercising legislative and quasi-judicial authority, and representing the citizens of Portland.

This measure if passed is effective January 1, 2009.

QUESTION: Shall the Portland Development Commission budget be subject to City Council oversight with financial and performance audits by City Auditor?

SUMMARY: Under the current Charter, the Portland Development Commission (PDC) is the City's urban renewal agency. This measure directs PDC to implement the City's urban renewal, affordable housing and economic development vision and goals. If authorized by state law, the Council will be the budget committee for the Commission. The Commission budget will be required to incorporate City goals and will be submitted to the Council in conjunction and conformity with the City budget process. The measure provides that the Commission shall advance social equity, involve the constituencies of the City, and promote home ownership and the creation and retention of multi-family housing.

The measure authorizes the Mayor to appoint and remove PDC Commissioners, with approval of the City Council. The measure provides that the Commission shall be subject to financial and performance audits by the City Auditor. The measure requires that the annual Commission report to Council include an evaluation of Commission activities with respect to City adopted vision and goals. The measure would be effective July 1, 2007.

EXPLANATORY STATEMENT

This measure is one of four recommendations by the 26 citizenmember Charter Review Commission.

It gives authority to the City Auditor to conduct financial and performance audits of the Portland Development Commission and provides budget oversight by the City Council.

Background

In November 2005, Portland City Council appointed a panel of 26 Portlanders to take the first comprehensive look at the City Charter since 1913. This independent volunteer citizen committee - the Charter Review Commission - represented a wide range of ages, ethnicities, experiences and backgrounds.

- Requires the Portland Development Commission to involve the constituencies of the City in promoting home ownership and the creation and retention of multi-family housing.

The measure helps define the mission of the Portland Development Commission and provides City Council with budget oversight and City Auditor with more authority to review the Portland Development Commission's work.

If passed, the measure will be effective July 1, 2007.

ANNEXATION OF PROPERTY AT 4960 IRELAND LANE REQUIRING VOTER APPROVAL

QUESTION: Shall the City annex a 2.1-acre property located at 4960 Ireland Lane and apply R-10 City zoning?

SUMMARY: West Linn Charter Section 3 requires that annexation of any territory be approved by the voters of the City. This measure, if approved, would annex a 2.1-acre parcel of real property located at 4960 Ireland Lane. The site is on the west side of Ireland Lane, south of Ridge Lane, and south of Rosemont Road. The West Linn City Council has determined that the proposed annexation complies with all relevant land use criteria for annexations.

EXPLANATORY STATEMENT

The West Linn City Charter requires voter approval of all annexations of property into city boundaries. The owners of property at 4960 Ireland Lane have submitted a request to annex 2.1 acres located on the west side of Ireland, south of Ridge Lane, and south of Rosemont Road. The site is adjacent to land within the city, and is part of an area entirely surrounded by the city limits.

The property is within the Portland Metropolitan Area Urban Growth Boundary. West Linn's Comprehensive Plan Map designates the property for Low-Density Residential Development. The city proposes to have the property zoned R-10, which is a zoning district consistent with the Comprehensive Plan Map designation. The R-10 zone allows single-family residential and certain institutional uses, with a minimum lot size of 10,000 square feet. If zoned R-10, the property could theoretically be divided into up to 7 residential lots - however, no land division is proposed as part of this annexation request. If approved for annexation, any development of the property would be required to comply with the City of West Linn's Community Development Code, including those provisions relating to citizen involvement and the protection of trees and other natural resources. The only special feature identified on this property is the beginning of a natural drainageway on the eastern portion of the property that flows southward.

On July 25, 2006, the West Linn City Council approved "Step One" of the annexation process for this site, finding that the proposed annexation met all relevant city code provisions governing annexations. On January 22, 2007, the West Linn City Council considered the fiscal and community impacts to the city of the proposed annexation. Each new dwelling unit on the site would result in \$23,272 of payments to offset costs to roads, sanitary sewers, storm sewers, water service, and parks.

The West Linn Municipal Code requires an explanatory statement to accompany any annexation measure with "an unbiased summary of the fiscal impacts on the public infrastructure" prepared by City staff and based on a methodology that was completed in 2004. Staff has reviewed this methodology and concluded that each unit of potential new residential development may result in a one-time unrecovered cost of \$13,696 per dwelling unit. It is anticipated that this annexation, prior to development, would result in additional annual property tax revenues for the City of West Linn of \$1,611. If fully developed, this annexation may result in \$1,232 additional annual property tax revenues for each new dwelling unit to the City of West Linn.

This measure, if approved, would annex a 2.9-acre parcel of real property located at 2590 Debok Road. The site is at the northern terminus of Debok Road, near Wisteria Court and Tamarisk Drive. The West Linn City Council has determined that the proposed annexation complies with all relevant land use criteria for annexations.

The West Linn City Charter requires voter approval of all annexations of property into city boundaries. The owners of property at 2590 Debok Road have submitted a request to annex 2.9 acres located at the northern terminus of Debok Road where it splits into Wisteria Court and Tamarisk Drive. The site is adjacent to land within the city on three sides. On the north side the property is adjacent to the Portland Metropolitan Area Urban Growth Boundary.

The property is within the Portland Metropolitan Area Urban Growth Boundary. West Linn's Comprehensive Plan Map designates the property for Low-Density Residential Development. FIVE-YEAR OPERATING LOCAL OPTION LEVY FOR POLICE SERVICES

QUESTION: Shall City levy 84.57 cents per \$1,000 of assessed property value annually for five years starting 2007-08 for police services?

This measure may cause properly taxes to increase more than three percent.

SUMMARY: This measure may be passed only at an election with at least 50 percent voter turnout,

This measure provides a levy on property of 84.57 cents per \$1,000 of assessed property value each year for five years, beginning with the 2007-08 fiscal year.

The funds from the levy will allow the City to retain the 12 police officers funded by the current levy, which expires on June 30, 2007. The funds would be used to pay salary and benefits for the police officers, as well as other operating expenses and capital costs of providing police services.

EXPLANATORY STATEMENT

This measure is identical to one submitted to voters in the March 13, 2007 special election. That measure was overwhelmingly approved (72%) by those who voted, but the election did not count because fewer than 50 percent of the city's voters submitted ballots, as required by state law.

The same requirement applies in this election. If approved, this measure would allow West Linn police services to continue at current levels for five years. For many years, West Linn's police services have been paid for in part by a special operating levy that is only good for a maximum of five years. The current police levy is 75.5 cents for each \$1,000 of assessed property value (AV). It expires on June 30 of this year. The proposed levy renewal is for 84.57 cents per \$1,000 AV. It would replace the expiring levy, not be in addition to it.

The proposed levy was calculated based on all of the costs that go into providing police services, including personnel costs, materials and equipment (including police car replacements), fuel and maintenance, health care and retirement costs. Those costs have risen faster than the increase in revenue from the existing police levy.

Since 2002, the last time voters approved a police levy, the city's population has increased by 3.2 percent. This has resulted in increased calls for police services. Over the same period, increases in identity theft and property crimes in West Linn have been significant due to the methamphetamine problem. The perpetrators of these crimes usually do not live in West Linn, but responding to and investigating victims' calls impacts police resources and staffing levels.

Local option levy would maintain current level of police service. Currently, the West Linn Police Department has 35.5 employees. Thirty are full-time police officers and 5.5 are support personnel. Renewal of the local option levy would continue current police services including: emergency response, neighborhood patrol, school resource officer, crime investigation, traffic enforcement, code enforcement, animal control and the canine unit.

If the proposed levy does not pass, your property taxes would decrease by a rate of 75.5 cents per \$1,000 AV. Corresponding reductions in City services would also be required, or new sources of revenue found. The current police levy provides approximately \$1.7 million a year in revenue - equal to 40% of the Police Department's budget. Without replacement revenue. the City would need to cut services. Police services would be reduced. Other city services, including the library and parks and recreation, could also be reduced in order to free up funding to operate the police department at a minimum level required for public safety.

Proposed levy would be 3% more than current tax rate.

This measure, if approved, would result in an increase of 9 cents per \$1,000 AV, or 3 percent more than the current combined city tax rate. For a home with an assessed value of \$260,000, the proposed levy would result in a property tax increase of about \$24 a year.

ARGUMENT IN FAVOR

As insurance professionals, we support passage of Measure 3-267.

West Linn residents are known for living in a safe community, even winning national recognition for it. A strong police presence is needed to both prevent crime and to apprehend those that commit crimes. It is very important that current levels of police officers be maintained. If the criminal element draws the conclusion that West Linn is an easy target, accurately or not, then everyone will be at increased risk.

Identity theft is on the rise. It takes a well-trained police force to capture the culprits of identity-theft. If we reduce our police force the officers most likely to be laid off are the investigators.

We recognize the most frequent loss that occurs for homeowners is theft. Even with an insurance policy most homeowners will suffer a large share of the theft loss due to high deductibles. Patrol officers work at all hours of the day to provide the needed presence to discourage theft, and to apprehend those that commit their crimes anyway.

It is no secret that the Portland region has a Meth drug problem. This and similar addictions induce people to commit crimes to generate the money to support their habits. Though West Linn has been relatively free of Meth labs, our citizens have been regularly subjected to the thefts that come with the regional problem.

Please vote in favor of Measure 3-267.

ARGUMENT IN FAVOR

We urge you to vote for approval of Measure 3-267, a local option levy for West Linn Police services beginning July 1, 2007. This levy merely continues the current levy that expires June 30, 2007. As with the current levy, the proposed levy will fund 12 police officers (or slightly less than one-half of the 30 sworn officers in West Linn). In other words, this levy continues to fund exactly the same number of police officers that the City now has on the force.

The proposed levy is an increase of 9.3 cents per \$1,000 of assessed value. The increase from the current rate of 75.5 cents per \$1,000 to 84.57 cents per \$1,000 allows the City to continue police services at the current level for the next five years. The present levy of 75.5 cents is being increased because it will not provide enough revenue in the coming years to maintain current levels of police service due to projected increases in operating costs, fuel, health care, materials, equipment and supplies.

The amount of increase amounts to about \$24 per year for the average West Linn home, equivalent to 8 grande lattes.

Failure to pass Measure 3-267 will result in the reduction of the police force by 12 officers. West Linn is a desirable community with an excellent quality of life. The confidence and pride we have in our safety and security is a very significant factor in our high quality of life. Let's keep it that way!

STOP DEPLETING DISTRICT ASSETS!!

I am asking for your vote to help me make our Water District accountable to ratepayers. We should reject financial irresponsibility and poor management.

The CRW General Manager and board were **determined to sell 3.445** acres of industrial property for only \$92,500. Most of CRW's \$664,000 investment in the parcel from which this acreage was to be partitioned is attributable to these 3.445 acres. I contested this proposal for over a year and finally stopped it by making a personal offer (which, as I anticipated, they declined) of \$110,000. See CRW minutes for April, October, and November 2007, and Steve Mayes' 11/25/2006 article in *The Oregonian*. I did the same with a smaller parcel this February (again, my offer was refused and they put it on hold).

In the meantime, the board passed an 8% rate increase.

I have monitored CRW meetings for nearly 7 years, starting when a past board sold 20% of treatment capacity to Rockwood (with no prior discussion with the ratepayers of this district) and planned to sell another 20% to Gresham. These sell-offs and others anticipated could eventually have made it necessary for us, the ratepayers, to build a new plant to handle our own needs.

I believe commissioners should be supportive of good management, but should actively evaluate management actions and question those which appear fiscally or environmentally unsound. It is important to utilize the contribution of citizens who often have experience and valuable first-hand information that is not found elsewhere. They should not simply "rubber-stamp" management proposals.
