1. CALL TO ORDER at 4:35 p.m. by Ted Kunze. Board members in attendance were Ted Kunze, Gary Linton, Raeline Kammeyer, Roger Beebe, Matt Bunch, Greg Parker, & Dan Sandberg. Executive Director Laurie Bothwell, Executive Assistant Susan Wells were also in attendance.

2. BUDGET WORKSHOP

- a. Budget Review for 2017-18 and 2018-19
- b. 2018-19 Budget
 - i. Fees
 - 1. Fair Admission Free until 3 on Thursday in hopes of increasing attendance for Thursday. Recommended accepting this proposal.
 - 2. Admission & Parking Fees discussed leaving fees at same rates as Fair 2016. Recommended leaving rates unchanged for 2017.
 - 3. Commercial Vendor Fees Proposal to increase all vendor booth fees by 10%.
 - 4. Concessionaire Fees Proposal to increase commercial vendor rates by 25%, increasing flat fee to minimum of \$500. Proposed for-profit rate at 25%. Proposed non-profit rate at 20%.
 - 5. Alcohol Sales Proposed to allow walk-around alcohol sales except for Sections A & E (previously section F). Those are to remain family-friendly alcohol-free seating.
 - 6. Camping Fees Proposed to leave fair-time camping rates static, while increasing non-fair camping season to increase rates to \$25.00 + tax.
 - 7. Horse Stall Rentals Proposed to increase stall rentals to \$125.00 per month & increase late fees to \$35.00, increasing late fees for each offense.

- 1. Building Rental Fees No discussion to change fees.
- 2. Equipment Fees Will review and discuss.

c. Fairboard recommendations

- 1. Fair Admission: Recommended accepting proposal free until 3 (Thursday only).
- 2. Admission & Parking Fees: Recommended leaving rates unchanged for 2017.
- 3. Commercial Vendor Fees: Recommend to increase all vendor booth fees by 10%.

- 4. Concessionaire Fees: Increase commercial vendor rates by 25%, increasing flat fee to minimum of \$500. Proposed for-profit rate at 25%. Proposed non-profit rate at 20%.
- 5. Alcohol Sales: Recommend accepting allowance of walk-around alcohol sales in Rodeo except for Sections A & E (previously section F).
- 6. Camping Fees: Recommend leaving fair-time camping rates static, while increasing non-fair camping season to increase rates to \$25.00 + tax.
- 7. Horse Stall Rentals: Recommend increase stall rentals to \$125.00 per month & increase late fees to \$35.00, increasing late fees for each offense.
- d. Other Greg recommended setting up a subcommittee to evaluate equipment replacement needs and replacement schedule.
