Proclamation of March 2011 As Colorectal Cancer Awareness Month

The Clackamas County Health, Housing & Human Services Department, is pleased to present to the Board of County Commissioners an opportunity to proclaim March as Colorectal Cancer Awareness Month.

Colorectal cancer is one of only a few cancers that can be prevented through the use of screening tests, yet colorectal cancer remains the third most commonly diagnosed cancer, and the second most common cause of cancer deaths for men and women in the United States. Each year, tens of thousands of lives are lost to this disease.

Despite these staggering statistics, colorectal cancer is one of the most preventable, treatable, and beatable forms of cancer, especially when it is caught early. Wider use of proven screening tests could save more than half of these lives.

During the month of March, the H3S Department will help spread the word about the importance of screening and early detection in the fight against colorectal cancer. We will distribute information on screenings and early detection via local media outlets, and our own social media and outreach platforms.

Recommendation:

We recommend the approval of this Proclamation and that the Clackamas County Board of Commissioners join in celebrating colorectal cancer awareness by declaring March 2011 as Colorectal Cancer Awareness Month in Clackamas County.

COLORECTAL CANCER AWARENESS MONTH

PROCLAIMING THE MONTH OF MARCH, 2011 AS COLORECTAL CANCER AWARENESS MONTH

WHEREAS, colorectal cancer is the third most commonly diagnosed cancer and the second most common cause of cancer deaths for men and women in the United States; and

WHEREAS, the vast majority of colon cancer deaths can be prevented through proper screening and early detection; and

WHEREAS, the survival rate of individuals who have colorectal cancer is 91 percent when detected in early stages, versus only a 10 percent survival rate when colorectal cancer has spread to other organs; and

Request for an Exemption from Competitive Bidding and Authorization to use the Request for Proposal Method for the Clackamas River at Springwater Road Bridge (1446) Replacement

In order to use the Request for Proposals (RFP) method to obtain the services of a contractor to replace the bridge, the Board, acting as the Local Contract Review Board, must approve findings of the facts that justify the granting of an exemption from competitive bidding.

The Local Contract Review Board Rule C049-0650 and ORS 279C.335 and ORS 279C.400 require the following process for exemptions of this nature.

Before final adoption of the findings exempting a contract for a public improvement from requirement of competitive bidding, a public agency shall hold a public hearing. Notification of the public hearing shall be published in at least one trade newspaper of general wide circulation a minimum of 14 days prior to the hearing. The notice shall state that the public hearing is for the purpose of taking comments on the agencies draft findings for an exemption from the competitive bidding requirement. At the time of the notice, copies of the draft findings shall be made to the public. At the option of the public agency the notice may describe the process by which the findings are finally adopted and may indicate the opportunity for public comment. At the public hearing the agency shall offer an opportunity for any interested party to appear and present comment.

To meet these requirements this draft of the findings is being presented to the Board for the exemption from competitive bidding.

The Purchasing Manager caused an advertisement to be placed in the Daily Journal of Commerce on **February 14, 2011** notifying interested parties of the draft findings. The advertisement states that the draft findings were available at the Office of the Purchasing Manager and that a Public Hearing will be held on **March 3, 2011**. This meeting will be the last opportunity for receiving comments. If no comments are received that result in a revision of the draft findings the Board of Commissioners may, at its discretion, adopt these draft findings as the final findings for the exemption at the public hearing

Proposed Findings

A. Nature of the Project:

The purpose of this solicitation is for the County to select a firm or team that is qualified to perform heavy construction for a bridge replacement project that has unique and challenging site conditions, traffic control, environmental restraints, work space constraints, construction staging issues, and scheduling demands. The County is looking for a contractor who has the experience, capacity, and the equipment to perform the work correctly, on budget, and on time.

The purpose of this project is to replace the Clackamas River at Springwater Road Bridge. The existing structure is reaching the end of its service life and is considered functionally obsolete because the structure's footings are scouring, rust is compromising the steel stringers, lead paint on the steel truss is deteriorating, and several areas of the deck are spalling. In addition, the bridge has narrow lanes, the approaches to the bridge are narrow, and the bridge rails do not meet current crash test standards.

The existing Clackamas River at Springwater Road Bridge has eight spans totaling 500.5 feet in length. The existing bridge from south to north has 34 and 40 foot cast-in-place reinforced concrete deck girder approach spans built in 1954, a 180.5 foot steel Pratt truss constructed in 1930 and 42 foot cast-in-place reinforced concrete deck girder approach spans built in 1954. The concrete approach spans are 33 feet and 4 inches wide. The steel truss is 37 feet and 5 inches wide.

The proposed replacement bridge will be a 457 foot long post-tensioned, concrete girder bridge consisting of three spans south to north: 190 feet, 190 feet, and 77 feet each. The bridge's out to out width will be 50 feet and 6 inches.

Some of the complexities of this bridge replacement project include:

- Constrained working space to remove the existing bridge, construct a temporary detour bridge with approaches, construct a temporary work bridge and construct a new bridge.
- Constrained working space to construct new retaining walls.
- Schedule challenges and numerous construction sequencing activities to comply with the restricted in-water work period of July 15 to September 15, which is required to protect threatened anadromous salmonids.
- Maintaining vehicle traffic through the site during construction is required because no reasonable offsite detour
 exists. The nearest Clackamas River crossings are the Barton Bridge, approximately 5.5 miles upstream of the
 project and the I-205 Abernathy Bridge approximately 7.5 miles downstream. Springwater Road carries an
 average of 7,200 vehicles per day. The peak hour traffic on the bridge is 230 vehicles traveling southbound and
 530 vehicles traveling northbound.
- Clackamas River Drive is a road that is on the southwest side of the bridge and follows the south side of the river
 westerly or downstream to Oregon City. Clackamas River Drive has numerous landslides that sometimes
 become active during inclement weather. If Clackamas River Drive or land located above Clackamas River Drive
 slides during the project, traffic volumes through the project could significantly increase because there are no
 alternative routes.
- The intersection of Springwater Road and Highway 224 is in close proximity to the bridge. This intersection has
 poor horizontal and vertical geometry that causes the intersection to operate at a level of service 'F' during peak
 hour traffic, which occurs during the morning and evening commutes. Traffic backs up from the intersection to the
 bridge during the morning and evening commutes because the intersection of Springwater Road and Highway
 224 operates in failure during peak hour traffic.
- Carver Park is adjacent to the southeast quadrant of this project. Carver Park is a popular regional park for
 fishing, boating, rafting, and other river recreation. Additional traffic congestion on the project site occurs in the
 summer on days when temperatures rise above 75 degrees Fahrenheit, due to the high volume of people
 recreating on the river.
- River traffic through the site will need to be maintained during construction.
- A vibration impact study has been completed for the Carver Mobile Home Ranch. Due to the geology of the site and depending on the type of construction equipment used by a contractor, there are five mobile homes within fifty-five feet of anticipated construction activities. These home could develop cracks, settle or result in other damage that homeowners could associate with vibrations caused by construction activities, if the structures are subjected to vibrations over 0.6 inches per second (ips). The vibration impact study also indicates vibrations in excess of 0.2 ips are "unpleasant" to humans and vibrations of 0.7 ips are "intolerable". The vibration impact study indicates that people within 200 feet of pile driving may experience vibrations in excess of 0.2 ips, depending on the type of construction equipment used by the contractor. The contractor will be expected to address and mitigate the risks to structures adjacent to the project site.
- The northerly portion of the bridge will be constructed through an existing mobile home park. The contractor will need to maintain access to all the homes in a manner that will secure the site and not put residents at risk.

The anticipated completion date for the project is November 11, 2014.

₿. Estimated Cost:

The estimated construction cost is 9 to 11 million dollars.

Narrative description of anticipated cost savings from exemption to use the RFP method to C. obtain construction services:

Under the traditional low bid method the Contracting Agency is constrained in evaluating the potential bidders experience with projects of this nature. Therefore, the potential that the low bidder could underestimate the level of work necessary to meet the project requirements must be addressed to minimize the necessity for change orders that could impact the cost of the project. It is anticipated that the process of evaluating potential contractors experience with similar projects and soliciting cost proposals from those qualified contractors will minimize the County's exposure to changes in cost.

One of the important advantages of the RFP approach for this project is that the County will be able to evaluate various approaches and value engineering methodology along with experience and cost to determine the solution that best meets the needs of the County. This process is anticipated to result in substantial cost savings.

Additionally, the RFP process provides that the contract will be awarded as soon as practicable to the qualified proposer whose proposal is determined to be the most advantageous to the County which will maximize the current highly competitive construction marketplace.

All of the elements for traditional Public Improvement contracts will be in place to address Proposal Bond, Payment and Performance Bonds, Prevailing Wage requirements and contract language as required by ORS 279C.

Proposed alternative contracting and purchasing practices: D.

- The County desires to select the contractor using the following competitive process: 1.
 - Publicly advertise a Request for Proposals. a.
 - The contractor will be selected through an evaluation process that will consider the b. following criteria.

Firm Background

Points: 0 - 5

Describe your firm's history and capabilities. Include information identifying annual volume, financial/bonding capabilities, and stability in the marketplace. Provide information identifying the firm's strengths and special capabilities. Include a company-wide organizational chart.

Firm Experience and Success

Points: 0 - 10

Describe your firm's experience with projects of similar size, type, complexity, delivery methods, environmental requirements, and schedule limitations. Identify project(s) you feel to be close to this in terms of schedule, budget, and conditions.

Provide recent (completed within the past five years) examples of projects which required similar management, organization, skills and expertise to that required by this project. Identify one or more individuals in the organization who held responsible positions on each cited example.

Experience of Key Personnel

Points: 0 - 10

Provide a construction organizational chart that identifies key personnel and positions that would be assigned to this project. Include resumes for these key people (for example, project principle, project manager, superintendent, etc). Resumes shall include the individual's education, work history, length of tenure with the proposer, and relevant experience with similar projects. Indicate the firm's willingness to include a "key personnel" clause in the Contract for those personnel

Project Understanding and Approach

Describe your understanding of the project and the role your firm is requested to perform. Describe your team's planned overall approach to manage this project. Explain how you will approach the performance of the work outlined in the construction documents, including cost estimating, constructability reviews, construction planning, risk assessment and mitigation, and construction to complete the project.

Points: 0 - 35

Points: 0 - 10

Administration of Work, Project Scheduling Points: 0 - 20 and Coordination

How would you approach project scheduling, and coordination for this project? Describe your expertise in project scheduling and coordination. Describe what software or other tools you utilize in controlling schedules and the sequencing of the work for projects with tight time constraints and little flexibility. Describe your process for managing change.

Describe your approach to the schedule and how you will deal with the three allowed in-water work periods given the environmental regulatory agencies have indicated that there will be no extension given for the in-water work window for this project. Also describe how you intend to get this project completed in three seasons with all the restraints specific to this project. Describe your approach to managing time for material submittals and long lead time materials.

Describe your team's approach to coordinating all numerous items on this project that have competing interests.

Value Engineering

Describe your firm's methodology and experience with Value Engineering (VE). Identify any particular successful experiences and/or unique services in this area. Share any significant lessons learned on innovative delivery projects and provide a narrative on how you would approach the issues differently. How would you apply the lessons learned in those experiences on this project?

Does your team see any potential value engineering proposals that could be applied on this project that could save time and/or money? What are they and do you see any value engineering proposals being implemented?

Firm Workload Points: 0 – 10

Provide the status of current work within the firm in time and magnitude. Describe the firm's resources and commitment to supporting and ensuring the success of this project. Describe what percentage of their time each "key personnel" will be dedicated to this project.

8. Schedule of Prices/ Proposed Cost Points: 0 - 55

- c. The submitted Proposals will be reviewed and scored by the Selection Committee. Points will be awarded based on the relative merit of the information provided in response to the solicitation. The Selection Committee may ask Proposers to submit additional information to clarify their proposal. Supplemental information will only be received if it is in direct response to the committee's request. Any unsolicited information submitted by a Proposer after the closing date will not be distributed to the Selection Committee.
- **d.** The Selection Committee will provide a recommendation to the Board of Commissioners for their consideration.

E. Statutory Tests

1. Background:

ORS279C.335 requires that the Local Contract Review Board make certain findings as a part of authorizing the use of an Alternative Contracting Method. Clackamas County desires to use a Request for Proposals solicitation method to select a Contractor for this project. The Clackamas County Request for Proposals approach has been designed to fully comply with the tests of Oregon Public Contracts Statute ORS 279C.335 for alternative contracting methods:

- a. It is unlikely that the exemption will encourage favoritism in the awarding of public improvement contracts or substantially diminish competition for public improvement contracts; and.
- **b.** The awarding of public improvement contract under the exemption will result in a substantial cost savings to the contracting agency or the public.

2. <u>Test:</u>

a. Maximizing Competition:

The County will employ a competitive Request for Proposals process for selecting the Contractor where the firm's background, key personnel experience, firms experience, capacity and project approach will be evaluated. Additionally, the firms will provide value engineering analysis and competitive cost proposals to the County.

b. <u>Minimizing Favoritism:</u>

A publicly advertised Request for Proposals process will include a formal selection process to be used to select the Contractor through the process as described above.

c. Substantial Cost Savings:

It is anticipated that the process of evaluating potential contractors experience with similar projects and soliciting cost proposals from those contractors will minimize the County's exposure to changes in cost. Cost reduction approaches and value engineering will be evaluated as part of the selection process, which is anticipated to result in substantial cost savings. Additionally, the RFP process provides that the contract will be awarded as soon as practicable to the responsible proposer whose proposal is determined to be the most advantageous to the County which will maximize cost savings in the current highly competitive construction marketplace.

Recommendation; Staff respectfully recommends that the Board, acting as the Local Contract Review Board, consider the comments received from the public on the proposed findings and direct staff to revise the findings, if necessary. If no revisions are to be made, staff recommends that the Board adopt the findings and grant the requested exemption.

Approval of Amendment #1 to the Interagency Agreement with City of Lake Oswego/Lake Oswego Adult Community Center to Provide Social Services for Clackamas County Residents

The Social Services Division of the Health, Housing, &Human Services Department requests the approval of Amendment #1 to the Intergovernmental Agreement with the City of Lake Oswego/Lake Oswego Adult Community Center to provide social services to Clackamas County residents age 60 and over.

This is a budget adjustment that increases the Nutrition Services Incentive Program (NSIP) Reimbursement per meal rate to \$.80, adds Older Americans Act (OAA) Title III-C funding for the senior nutrition program and adjusts the number of contracted meals.

This amendment increases the agreement by \$10,315 for a new agreement maximum of \$54,865. This agreement is in the format approved by County Counsel as part of the H3S contract standardization project. No County General Fund dollars are involved. This amendment is retroactive back to the original start date of the contract, July 1, 2010; and continues through June 30, 2011.

Recommendation

We recommend the approval of this agreement and that Cindy Becker be authorized to sign on behalf of the Board of County Commissioners.

The Mission of the Johnson Creek Watershed Council is to inspire and facilitate community investment in the Johnson Creek Watershed for the protection and enhancement of its natural resources. The attached Partnership Agreement will allow Clackamas County Service District No. 1 (CCSD#1) to jointly fund and derive benefit from activities in the Johnson Creek Watershed which are beneficial to CCSD#1: a) public education and outreach work which promotes watershed health, b) watershed restoration, c) and monitoring that will improve watershed health.

APPROVAL OF A PARTNERSHIP AGREEMENT BETWEEN CLACKAMAS COUNTY SERVICE DISTRICT No. 1 AND NORTH CLACKAMAS URBAN WATERSHED COUNCIL FOR RIPARIAN BUFFERS, UPLAND TREE CANOPY, AND EDUCATION ACTIVITIES

The North Clackamas Urban Watersheds Council was formally recognized by the Clackamas County Board of County Commissioners in June, 2009 to advocate for the protection and enhancement of the Kellogg/Mt. Scott fish and wildlife habitat and improve water quality through partnership with public and private entities, habitat restoration projects, community education and outreach, and strategic planning.

The attached Partnership Agreement will allow Clackamas County Service District No. 1 (CCSD#1) to jointly fund and derive benefit from activities in the Kellogg/Mt. Scott Watershed which are beneficial to CCSD#1: a) public education and outreach work which promotes watershed health, b) stream and wetland buffer enhancement, c) and riparian restoration that will improve watershed health.

The Partnership Agreement specifies that CCSD#1 shall contribute \$10,000 each fiscal year until the Agreement expires in June 30, 2012, unless the Agreement is extended. The funds for FY2010-2011 are in CCSD#1's FY2010-2011 Surface Water Management budget. District counsel has reviewed the Agreement as to form.
