ORDINANCE NO. ZDO-229

An Ordinance amending Section 401 of the Clackamas County Zoning and Development Ordinance.

WHEREAS, House Bill 3099 was enacted by the 2009 Oregon Legislature to assist counties in updating land use regulations relating to farm land; and

WHEREAS, Houise Bill 3099 provides that the county may adopt amendments to its land use regulations required by HB 3099 without holding a public hearing; and

WHEREAS, the Department of Land Conservation and Development has been provided proper notice of the ordinance amendment; and

WHEREAS, the Department of Land Conservation and Development has acknowledged in writing that the proposed amendments conform the county's land use regulations to the amendments required by section 2 of the 2009 Act; and

WHEREAS, the Clackamas County Board of County Commissioners considered the proposed amendments at a business meeting on November 4, 2010; now therefore;

The Board of Commissioners of Clackamas County ordains as follows:

Section 1: Section 401 of the Clackamas County Zoning and Development Ordinance is amended as shown in Exhibit A hereto.

National Family Caregiver month presents an opportunity for families, nonprofit organizations and government entities alike to celebrate the ordinary people who are family caregivers providing care to loved ones. Every day, in every community caregivers assist friends, relatives, and loved ones with daily tasks, including personal care and homemaking as well as more complex health-related interventions like medication administration and wound care. These selfless, dedicated individuals are the backbone of our long term care system. The Family Caregiver Support programs allow individuals to remain with their families for as long as possible while helping to ensure the wellness of participating Caregivers.

Family Caregivers in Clackamas County identify that respite care is their number one need for selfcare. Providing respite care assistance to Family Caregivers ensures their ability to maintain their own health and enables them to continue providing optimum care to their loved one. The Clackamas County Family Caregiver Support program offers respite assistance, information about resources in the County as well as educational training. All Family Caregivers need to remember that is it a sign of strength to ask for help.

PROCLAIMING NOVEMBER -NATIONAL FAMILY CAREGIVERS MONTH

IN CLACKAMAS COUNTY

Whereas, November is National Family Caregivers Month, a time to honor, thank, support, assist, educate and celebrate our nation's more than 65 million, family caregivers and the 360,000 family caregivers in Oregon,

Whereas family caregivers are the **foundation of the long-term care** network nationwide and in Clackamas County,

Whereas 87% of all family caregivers provide an average of 20 hours per week caring for chronically ill, disabled or aged family members or friends and 13% of the family caregivers provide 40 hours or more of care per week,

Whereas family caregivers experiencing extreme stress have shown to age prematurely; this level of stress can take as much as 10 years off a family caregiver's life. At least **70%** of family caregivers identify health issues such as high blood pressure, depression, insomnia, heart problems, and diabetes as being directly related to their role as a family caregiver;

Whereas Clackamas County Family Caregiver Support Programs are entering their 10th year of existence in serving family caregivers in the County and have provided services to over 6,000 family caregivers in that decade;

Whereas Clackamas County Employee Assistance Program is to be commended, a component which supports county employees who serve as family caregivers through education, family medical leave, resources and referrals;

NOW THEREFORE, We, the Clackamas County Board of County Commissioners, do hereby declare that Clackamas County will observe the entire month of November, 2010 as Family Caregivers Month, and urge all citizens to take part in activities and observances designed to increase awareness and understanding of care giving and to encourage citizens to volunteer their time to assist caregivers in their communities.

Approval to Apply for a Three-Year Grant from the U.S. Dept. of Housing & Urban Development for Funding of a Resident Opportunities and Self-Sufficient Service Coordinator

The Housing Authority of Clackamas County (HACC), A Division of the Health, Housing and Human Services Department, requests Approval to apply for a Three Year Grant from the U.S. Department of Housing & Urban Development (HUD) for a Resident Opportunities and Self Sufficiency Service (ROSS) Coordinator.

HACC has been a past recipient of ROSS grant funds and currently has one Full Time Equivalent (FTE) ROSS Coordinator. HACC's ROSS Coordinator assists Public Housing families increase earned income, reduce or eliminate the need for welfare assistance and make progress toward achieving economic independence and/or housing self-sufficiency.

The total amount of the award for a three-year grant term is \$240,000. HACC will use grant funds to continue to cover the salary and benefits for HACC's one Full Time Equivalent (FTE) ROSS Coordinator over three years including administration and training costs. No County General Funds are involved if the grant is awarded.

The ROSS Coordinator will:

- Coordinate a Local Program Committee with service providers to ensure that program participants are linked to supportive services needed to achieve self-sufficiency.
- Mark the program to residents.
- Provide general case management, which includes intake, assessment, education, and referral of residents to service providers in the general community.
- Coordinate and sponsor educational events, which may include subjects relating to health care, job search seminars, and life skills training.
- Facilitate the formation of Self-Help groups.

Recommendation

HACC recommends the approval to apply for the ROSS grant and further recommends the acceptance of the award if funded; and that the Housing Authority Executive Director be authorized to sign all documents necessary to accomplish this action of behalf of the Board.

Approval to Apply for US Department of Housing and Urban Development HOPE VI Revitalization Grant

The Housing Authority of Clackamas County (HACC), a Division of the Health, Housing and Human Services Department, requests Approval to apply for a US Department of Housing and Urban Development (HUD) HOPE VI Revitalization Grant (HOPE VI). The maximum amount of funds to be awarded is \$22,000,000.

The HOPE VI funds can be used to cover:

- Capital costs of major rehabilitation, new construction and other physical improvements;
- Demolition costs of severely distressed public housing;
- Acquisition costs of off-site construction; and/or
- Community and supportive service programs for residents, including those relocated as a result of redevelopment efforts

This is a new grant source for HACC. The HOPE VI serves a vital role in HUD's efforts to redevelop Clackamas Heights Public Housing in Oregon City. Grant funding, if awarded, will be used to demolish all units at Clackamas Heights, rebuild new units and community facilities, and provide community supportive services to residents.

As part of the grant application, the Board is required to approve and sign Attachment 30, HOPE VI Revitalization Applicant Certifications. Upon Board approval, HACC will submit the HOPE VI grant application due November 22, 2010. There is no impact on County General Funds.

Recommendation

HACC recommends the approval to apply for the HOPE VI Grant and the approval of Attachment 30 for signature by the Board Chair. HACC further recommends the acceptance of the award if funded, and that its Executive Director be authorized to sign all documents necessary to accomplish this action on behalf of the Board.

Approval of a Contract with LRS Architects Inc., for Land Use Review, Construction Documents, Contract Administration for the Addition of a Vehicle Sallyport, Court Holding and Courtroom to the Clackamas County Courthouse

In January 2009, the County began a project to develop a Facilities Master Plan for Public Safety Operations. The prime objective of the Master Plan was to examine the current space holdings of the Sheriff's Office, create options for consolidation and efficiency, prepare a priority list of improvements for existing facilities and explore options for providing additional space to address the Sheriff's Office needs for the next ten years.

One of the findings of the Master Plan was that the Civil Sheriff operations at the Courthouse needed additional capacity to facilitate the movement of inmates through the Courthouse. Additionally, the need for additional courtroom space has been an ongoing issue due to the limited amount of space available in the Courthouse. The project team with the assistance of LRS Architects examined the programmatic needs and space requirements to address as many of the needs as practicable and developed a concept plan that was approved by the team. This contract will take the project through a process that will result in final design and construction documents. LRS was selected for this contract in compliance with LRCB Rule C-046-0500 (4) (f) that provides for selection of a single candidate for a personal services contract.

Funds for this project will be provided through a combination Courthouse Security Program and available budgeted funds.

This Contract has been approved as to form by County Counsel.

RECOMMENDATION

Staff respectfully recommends that the Board approve the Contract with LRS Architects for Land Use Review, Construction Documents, and Contract Administration for the Addition of a Vehicle Sallyport, Court Holding and Courtroom to the Clackamas County Courthouse in the amount of \$172,384.00.
