- 1. Call to Order at 7:00 p.m.
- 2. Land Use Applications:
 - a. Z0346-23-ZAP & Z0347-23-SL, applicant Mann Construction, property owner Enoh & Danielle Man & Cornel & Vitoria Man, 20750 S Beavercreek Road, zoned RRFF5, 56.22 acres, requesting a zone change from RRFF5 to RA2 and a 28-lot subdivision for future development of single-family dwellings.
 - i. Need to confirm if the Weiler Farm appeal has moved forward.
