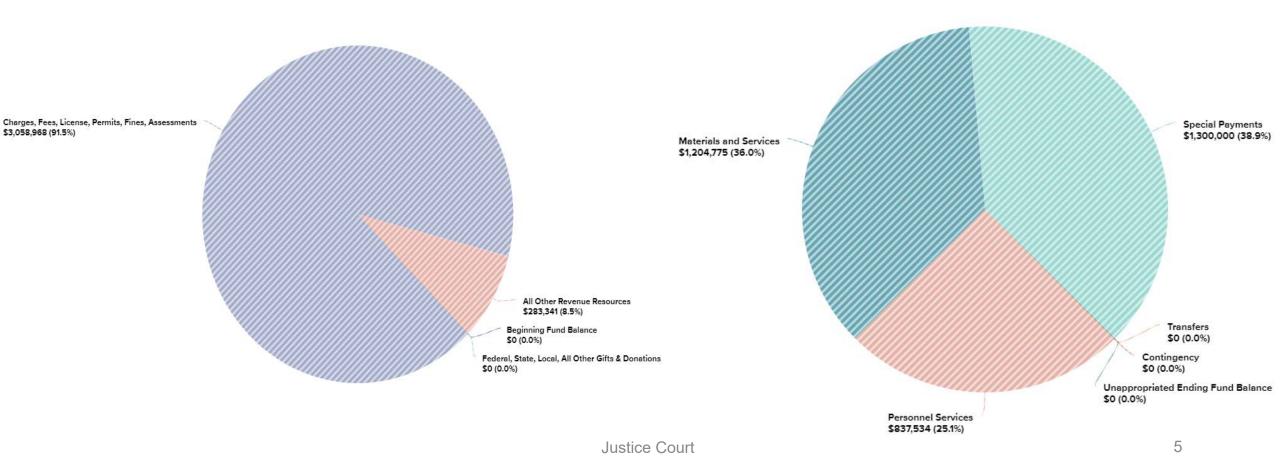

Criminal Division During COVID-19	Implement virtual court using Zoom trials to expand access to justice
	Increase options for communicating with the court by using technology to allow entry of a not guilty plea online
	Establish secure email for communications with the public
	Retain regular business hours from 8am-5pm, Monday through Friday, allowing telephone contact with the court
	Implement in person violation trials using approved safety protocols including masks, social distancing and disinfecting surfaces after each trial
Civil Division	Implement County SharePoint technology to allow electronic filing of pleadings and legal documents with the court. Clerk can add information to the document such as a case number or court appearance date and electronically return the document to the filer for service on the parties

Significant Policy and/or Financial Issues

DESCRIPTION	IMPACT
Criminal Division A moratorium on vehicle equipment violations and driver's license status offenses in addition to police policies that limited contact with drivers during COVID-19 reduced the number of violation cases filed by police agencies from 1,417 per month in FY 19/20 to 991 per month in FY 20/21.	Reduction in revenue
Civil Division Governor executive orders and Oregon law established a moratorium on evictions for nonpayment of rent from April 1, 2020 through June 30, 2021, reducing the number of eviction cases filed from 2,014 cases in calendar year 2019 to 735 cases in calendar year 2020.	Reduction in revenue
