# Skylands Neighborhood Association Minutes of the 2023 Annual Meeting – December 14, 2023

#### Skylands Road Maintenance Committee Report - Steve Donaghy

Steve Donaghy, chair of the Road Maintenance Committee (the "Committee"), provided an overview of the significant progress the neighborhood has made over the past few years to improve our roads. We have a plan to continue road improvements in the summer of 2024 which will include: the upper portion of Green Bluff Drive, city portion of Crestline Drive, and all of Skyland Circle. #### Cone Park Update - Paul Zaninovich

Paul provided an update on the status of the Cone Park lot in the absence of Henry Morse and Dina Alexander, the current owners of the lot. After extensive work by Henry and Dina, there was insufficient voluntary support in the neighborhood to create an HOA. As such, that opportunity for a long-term solution to keep the lot as a park has passed. Henry and Dina are interested in continuing to preserve the lot as a park for another 8-10 years and are seeking other investors. # **Skylands Road Maintenance Committee Report:**

Road Committee: Steve Donaghy, David Roche and Brad Hart

When we formed our committee in 2021, our objectives were to:

- Document neighborhood road issues
- Engage city and county decision-makers
- Set priorities for road repair projects
- Create Road Maintenance Funds to support improvements

We have a lot to be thankful for.

Due to the support of the Skylands community, the city of Lake Oswego and Clackamas County, we have improved many of the roads in our neighborhood over the last two years, including:

- Most of Green Bluff Drive
- More than half of Bergis Road
- Wayside Lane
- Eastridge Lane
- Most of Crestline Drive
- Upper Cherry and Cherry Circle (County Sections)
- Part of Skyland Drive
- Part of the Skyland Circle stem

We plan to continue our road improvements in 2024. Our objectives include:

- Complete Green Bluff Drive (upper portion)
- Complete Crestline Drive
- Complete Skyland Circle (city section)
- Improve as much of the county section of Skyland Circle as we can.

We have received a commitment from the city of Lake Oswego for additional financial support in 2024. We will also be asking for additional help from our neighbors so that we can finish the job.

### **Cone Park Update:**

To stop the Cone Park lot on Skylands Circle from being developed into a lot with a house, Henry Morse and Dina Alexander (2 lot owners on Skylands Circle) purchased the "park" lot in 2022 with the intention of exploring how the neighborhood could create an HOA to own the park indefinitely. While they have worked extensively on a solution, there was insufficient voluntary support in the neighborhood to create an HOA, so that opportunity for a long-term way to keep the lot as a park has passed.

Dina and Henry and still interested in preserving the lot as a park for a while longer and are now soliciting interested neighbors who might want to invest as part owners of the park, to hold it for another 8-10 years, with the expectation that at the end of that time the lot would be sold. While this doesn't keep the lot as a park on a long-term basis, it does keep it as a park for the near to mid-term.

Those interested could consider this as an investment in a piece of real estate, with the possibility to earn a return on the investment once it has been sold. For those who are interested who have funds in an IRA, we understand there is a way that this investment could be made through a self-directed IRA.
