Update on Co-Chair Selection	Chair Bernard announced that Mayor Hodson was chosen by the C4 Executive Committee to serve another year as the C4 Co-Chair.
Value Pricing Presentation - ODOT	Michael Mason (ODOT) presented on the process and status of the HB 2017 direction for ODOT to study the impacts of Value Pricing on I-5 and I-205, north of the Wilsonville and South of the Columbia River. No action was taken and the full

	The final recommendation from Value Pricing Policy Advisory Committee will be made on June 26, 2018.
Willamette Falls Update	Willamette Falls Legacy Project: John Southgate (Clackamas) shared a brief history and status update of Willamette Falls Legacy Project. Presently, the property owner has signed permits allowing the Riverwalk work to continue and construction could begin in early 2019.
	Willamette Falls Locks: Trent Wilson (Clackamas) shared the status of the SB 256 State Commission on Willamette Falls Locks, who had their first meeting on April 4, 2018. The Commission will work towards finding a transferee to accept ownership of the Locks from the Corps.

C4 Retreat Agenda Draft Discussion	Staff presented a blueprint agenda for C4 to review. C4 members agreed to keep the retreat dedicated solely to transportation issues, specifically addressing county-wide goals and creating plan to achieve those goals.
Updates/Other Business:	Housing Needs Assessment: County staff is still working with the contractor to narrow down the scope of the work, per the recommendation from C4. Additionally, staff is working with DLCD on how to access state funding recently made available to support the project. More information is expected soon.
