EXECUTIVE SUMMARY:

The proposed assessment area(s) listed in Exhibit A - New Service District No. 5 (CCSD5) Petition Assessment Area attached to the proposed Board Order, would be formed in response to property owner requests for street lighting in existing neighborhoods under District Rule 4.020. Staff evaluated the existing conditions, prepared petition materials for neighborhood sponsors and followed up with informational mailings after the initial signature gathering phase. If approved, County staff will work with PGE to achieve a design appropriate to the neighborhood's needs.

Notice of the time and place of this hearing was mailed by first class mail to the current addresses as listed by the Clackamas County Assessment office. The notice specifically noted that a public hearing was scheduled for November 7, 2024, to hear objections or to file a remonstrance against the approval of the new assessment area. Pursuant to statute, a minimum of 50% of the affected property owners in a proposed assessment area must remonstrate to deny the formation of the new assessment area.

RECOMMENDATION:

If remonstrance's from more than 50% of the property owners in a proposed assessment area for street lighting are received by the end of this public hearing, it is recommended that the Board of County Commissioners, acting in the capacity of the governing body of CCSD5, note the remonstrated assessment area(s) in Section 1 of the Board Order (thereby removing that assessment area from the formations), which will allow CCSD5 to proceed with the formation of the remaining assessment areas for street lighting.

Whereas, this matter coming before the Board of County Commissioners, acting as the governing body of Clackamas County Service District No. 5 (DISTRICT), a street and highway lighting service district organized under ORS Chapter 451 and formed pursuant to Ordinance No. 70-1078 (Dec. 11, 1970);

Whereas, under ORS 451.490 and 451.495, the DISTRICT may finance the construction, operation or maintenance of the service facilities through several means, including assessments against the property in the DISTRICT that is directly benefited by the service; and

Whereas, it appearing to the Board that certain properties, particularly those identified in the attached Exhibit A - New Service District No. 5 (CCSD5) Petition Assessment Area, have requested street light service under District Rule 4.020, and the formation of new assessment areas within the DISTRICT is necessary to finance the installation and illumination of street lights in these new areas; and

Whereas, it further appearing to the Board that the method of financing the operation and maintenance of service facilities is to be assessments against the properties benefited by street light facilities as authorized by ORS 451.495; and

Whereas, it further appearing to the Board that it adopts certain assessment rates each year that reflects the cost of providing lighting services, and has done so most recently by Resolution No. 2022-46, as shown in the attached Exhibit B – Service District No. 5 (CCSD5) Rate Schedules, as updated and as amended; and

Whereas, it further appearing to the Board that the Board's adopted rate schedules Exhibit B – Service District No. 5 (CCSD5) Rate Schedules, as updated and as amended, may be applied to each new assessment area, including those listed in Exhibit A - New Service District No. 5 (CCSD5) Assessment Areas, at a schedule commensurate with street lighting services each area receives and at a fractional year assessment pro-rated from the date of installation; and

Whereas, it further appearing to the Board that Clackamas County through adopted District Rules and Regulations, has given notice of public hearing as required by Order Number 94-1368 and ORS 451.495, and that said public hearing was duly held on the <u>7th</u> day of November, 2024, as noticed.

- 1. - 2. All properties in the Assessment Areas described in **Exhibit A New Service District No. 5 (CCSD5) Assessment Areas** that are not subject to a remonstrance are hereby subject to an assessment for street lighting.
- 3. That an assessment roll be prepared by the County showing the amount of each yearly assessment, the property against which it has been assessed, the owner thereof, and such additional information as is required to keep a complete and permanent record of the assessment.
- 4. That the Department of Transportation and Development proceed to facilitate the installation of the street lighting in accordance with DISTRICT rules and guidelines.

Rate schedules were established by Commissioners' Resolution No. 2022-46, to reflect the cost of providing street lighting service in the District, effective fiscal year 2022-2023 as follows:

To Whom it May Concern,

We are opposed to adding street lights to Hugh Avenue in unincorporated Clackamas County. We have lived on Hugh Avenue for 14 years and as residents we do not see the need for street lights to be placed for a number of reasons which we have stated below.

The yearly cost is high and adds a burden to our budget.

We have seen very little to no crime on the block and feel porch lights have provided enough lighting needs for crime prevention.

Additional light could affect our son who already suffers from insomnia. Based on the location of the existing pole, the street light would be placed directly in front of his bedroom window.

We also feel the lights would hurt migratory birds by disorientating them and they could possibly crash into the houses or other structures on the street. Street lights can also harm other wildlife that live on our street including wild rabbits, coyotes, skunks and raccoons.

We also enjoy being able to see the stars from our front porch which we would not be able to do with street lights especially because a street light would be placed directly in front of our house.

Please do not add street lights to Hugh Avenue.
