#### BACKGROUND:

The Clackamas County Public Health Division of the Health, Housing and Human Services Department has been working over the past year with national, state and neighboring public health agencies, hospitals, EMS providers, Public Information Officers and Emergency Management to be better coordinated and prepared for the low possibility of a suspect Ebola case in our community. To date, Clackamas County has actively monitored 24 travelers from the affected West African countries. Active monitoring involves obtaining the temperatures and symptoms screening of these individuals twice per day for 21 consecutive days.

Public health continues to work to be prepared for new emerging diseases such as Ebola and MERS (Middle Eastern Respiratory Syndrome). Information on activities being conducted by the Public Health Division and education for the general public will be shared.

## Background and Status on Ebola Virus Disease

Ebola Virus Disease is a viral hemorrhagic fever causing severe illness in which 50-90 percent of those infected die.

The 2014 Ebola outbreak is the largest in history, resulting in 17,749 known cases & 6,489 deaths.

There have been no cases in Oregon.

Current Status: Liberia is now Ebola free. Individuals traveling from Sierra Leone and Guinea still undergo airport screenings & active monitoring upon arriving to the US.

# Clackamas County Public Health – Ebola Planning Efforts

Clackamas County and regional partners took precautions to this emerging threat by:

- Working with national, state and neighboring public health agencies on improving protocols for planning and response to disease threats.
- Partnering with regional hospitals and EMS providers to improve coordination
- Activating the H3S / Public Health Department Operations Center at a low-level with support and assistance from Emergency Management
- Developing communication messages with Public & Government Affairs staff
- Monitored 24 travelers from the affected West African countries living or staying in Clackamas County.

#### BACKGROUND:

On March 17, 2015, the Department of Transportation and Development (DTD) asked the Board to adopt a utility inspection fee and a credit/debit card service fee. Approval of the utility inspection fee was in anticipation of the passage of a Senate Bill allowing counties to recoup costs associated with utilities using our right of way. Ultimately the bill did not pass. In light of this, we are asking the board to remove the fee from the adopted fee table.

Our Managing for Results performance goals include improving our customer service and streamlining the permitting process for our customers, so during the same meeting in March, DTD asked the Board to adopt a card service fee so that we could meet our customers' needs by expanding the use of credit and debit cards in the department.

As this was the department's first venture into diversifying our credit/debit card usage, we were unaware that there are two options for collecting a service fee: a department managed model and a bank managed model. The department managed model is manually collected at the front counter by our permitting staff and requires multiple transactions and the customer must sign two separate receipts; whereas, the bank managed model is collected by the bank on the back end and is shown as a separate transaction on the customer's credit card statement. Under either model, customers may choose another payment method and avoid the fee entirely.

We originally requested the adoption of a department managed model; however, as we learned more about the process, we found that the department managed model is cumbersome and confusing for both customers and staff and ultimately we recommended a bank managed model.

Because the County is not collecting the fee, we would not need to adopt a bank managed fee into the code and any minor adjustments would be done administratively by the bank; therefore we are requesting that the Board repeal the DTD department managed credit/debit card service fee. Though no County "fee" will be collected, customers will be informed that a bank service fee will apply if they choose this method of payment.

#### BACKGROUND:

The Clackamas County Public Health Division (CCPHD) of the Health, Housing & Human Services Department requests the approval of an Agreement with Clackamas County Health Centers Division (CCHCD) to build mental health services capacity at the Oregon City and Sandy SBHC's. This Agreement provides the basis for a cooperative working relationship for the provision of a mental health specialist at the SBHC's. This agreement will allow earlier access to mental health services, reducing the number of crisis incidents. This agreement is funded with grant money received through the Local Public Health Authority (LPHA).

This contract is effective July 1, 2015 and continues through June 30, 2017. The agreement is retro-active due to late receipt of funding approval by the State.

#### I. Purpose

This agreement provides the basis for a cooperative working relationship between the Clackamas County Public Health Division herein referred to as "CCPHD," and the Clackamas County Health Centers Division, herein referred to as "CCHCD," with the common goal of building capacity of Mental Health services to the School Based Health Center (SBHC) program. The funds provided under this agreement shall only be used to support activities related to the Mental Health Expanision Project within the SBHC.

#### II. Scope of Work and Cooperation

CCHCD agrees to:

- A. Provide a .8 FTE mental health specialist 2 at Oregon City SBHC and Sandy SBHC.
- B. Provide services that are culturally and linguistically appropriate for their target population.
- C. Track data related to mental health encounters and submit encounter data for all billable and non-billable services to State Program Office (SPO) four times during the contract period (January 15, 2016; July 15, 2016; January 15, 2017; and July 15, 2017)
- D. Participate in monthly check-in meetings with SPO.
- E. Submit 3 mid-project reports in December 2015, June 2016, December 2016 and a final report in June 2017. Guidance will be given on expected report content.

CCPHD agrees to:

- A. Work with Oregon City and Oregon Trail School Districts to promote the mental health specialist services.
- B. Submit 3 mid-project reports in December 2015, June 2016, December 2016 and a final report in June 2017.
- C. Serve as liaison to SPO.
- D. Participate in monthly check-in meetings with SPO.
- III. Liaison Responsibility
  - A. Facilitate communication and cooperation between the CCHCD and CCPHD and school districts to provide mentalhealth services in the SBHC'S.
  - B. Complete the scope of work as outlined under Section II.

IV. Compensation

CCPHD's obligations under this agreement are subject to receipt of grant funds from the State of Oregon for Program Element #44: School Based Health Centers.

The maximum amount available for CCHCD under this agreement shall not exceed \$325,850.00.

#### VI. Amendments

This agreement may be amended at any time with the concurrence of both parties. Amendments become a part of this agreement only after the written amendment has been signed by both parties and the Department Director.

#### VII. Term of Agreement

This agreement becomes effective July 1, 2015 and is scheduled to terminate June 30, 2017.

This contract may be terminated by mutual consent of both parties, or by either party, upon 30 days' written notice.

This agreement consists of seven (7) sections plus the following exhibit which by this reference is incorporated herein.
