**EXECUTIVE SUMMARY:** This is a project agreement between Clackamas County and the Oregon Department of Transportation (ODOT) for a planning study to develop a design solution for the one-mile gap in the I-205 multiuse path (MUP). The project will assess up to three route alternatives and develop design concepts for evaluation leading to a preferred alignment selected through the alternative analysis process.

The I-205 MUP extends 16.5 miles from Vancouver, Washington to SE 82nd Drive in Gladstone. Currently it provides a continuous off-street path for pedestrians and bicyclists, with the exception of a one-mile gap between SE Herbert Court and Hwy. 212, in Clackamas County. The I-205 Multi-user Path Alternatives Development Study Path will engage community members and stakeholders to develop an alignment and design solution for the one-mile gap to improve safety and accessibility for all transportation modes.

Clackamas County applied for and obtained a grant through the Metro Regional Flexible Funds Allocation (RFFA), which is a process Metro conducts every three years to decide how to spend the region's allotment of federal transportation dollars. The County will complete the work as a Supplemental Project under the County's Local Agency Certification Program Agreement No. 73000-00029343:1 with ODOT. The project will be funded with \$1,094,857.64 from the RFFA and \$125,311.36 by County Road Fund (10.27% match). The overall project cost is \$1,220,169.00.

**RECOMMENDATION:** Staff respectfully recommend that the Board of County Commissioners sign the attached Supplemental Project Authorization No. 73000-00029343:2 with the Oregon Department of Transportation for the I-205 Multi-user Path Alternatives Development Study.

#### B. SUPPLEMENTAL PROJECT AUTHORIZATION TERMS

- 1. <u>Applicable Provisions:</u> Except as otherwise modified by the terms of this Supplemental Project Authorization, the Project is subject to the terms and conditions of the Program Agreement, including the Standard Provisions and Special Provisions specified in the Project Details Table above, which are incorporated into this Supplemental Project Authorization by reference as though fully set forth herein.
- 2. <u>Scope:</u> This planning Project includes conducting the I-205 Multi-user path alternatives development study described in the Project Details Table above. The Project location and study area are shown on Attachment 1 Project Vicinity Map.
- 3. ODOT Costs: The Parties agree that ODOT will perform risk-based Project oversight in accordance with the Program Agreement. A preliminary estimate for the cost of ODOT's work is shown above in the Project Details Table under Informational Details. The Parties agree that ODOT services to be performed in excess of this preliminary estimate shall be addressed as provided in Paragraph V.3 Subsection g. of the Program Agreement. Certified Agency understands that ODOT's costs are estimates only and Certified Agency agrees to pay ODOT's actual costs incurred per the Terms of this Supplemental Project Authorization. On a quarterly basis, ODOT will provide Certified Agency a statement of costs expended by ODOT.
- 4. <u>Funding:</u> A combination of federal, state, and local funds may be expended on the Project as detailed in the Project Details Table above, subject to the limitations and obligations set forth in

the Program Agreement and this Supplemental Project Authorization. Federal and State funds for a project shall be limited to the amount shown in the Funding Details section of the Project Details Table above.

- a. Certified Agency guarantees the availability of Certified Agency funding in an amount required to fully fund Certified Agency's share of the Total Project Costs, as shown in the Project Details Table, and in accordance with the Funding provisions in Paragraph V.3 of the Program Agreement.
- b. Certified Agency understands and agrees that federal funding for this Project is contingent upon FHWA's approval of each funding request. Any work performed outside the period of performance approved by FHWA or outside the Project Scope will be considered non-participating and paid for at Certified Agency expense.
- c. ODOT will submit requests for federal funding authorizations to FHWA by Project phase. The ODOT Project Contact or designee will provide Certified Agency with a written notice to proceed for each Project phase when FHWA approval has been secured and funds are available for expenditure on the Project.
- d. With the notice to proceed, ODOT will provide Certified Agency with a copy of the USDOT FHWA Federal Aid Project Agreement between ODOT and FHWA for this Project, which contains the information required of pass-through entities by 2 CFR 200.332(a)(1).
- 5. <u>Invoicing:</u> Certified Agency shall submit invoices for Project progress billings in accordance with the invoicing provisions in Paragraph V.5 of the Program Agreement.

### 6. Period of Performance:

- a. Begin and End Dates: The Project period of performance begins when both the initial FHWA Project authorization has been received by ODOT and a notice to proceed for the first phase of the Project has been issued by the ODOT Project Contact. The Project period of performance ends on the Project End Date shown in the Project Details Table. All Project work must be completed within the period of performance.
- b. Project End Date Changes: The Project End Date may be changed upon written approval by the ODOT Project Contact, which shall be incorporated by reference into this Supplemental Project Authorization. To extend the Project End Date, Certified Agency shall submit a written request to the ODOT Project Contact as soon as Certified Agency becomes aware that a schedule change is necessary, but no less than sixty (60) calendar days prior to the authorized Project End Date. The ODOT Project Contact will coordinate with ODOT Program and Funding Services to seek authorization from FHWA prior to approving the extension request. FHWA authorization for extensions is not guaranteed. Any work performed outside the period of performance authorized by FHWA will be nonparticipating and paid for at Certified Agency expense.
- 7. Project Useful Life: The useful life of the Project is 20 years.
- 8. <u>Project-Specific Modifications:</u> Reserved.

- 3. This Supplemental Project Authorization may be executed in several counterparts (facsimile or otherwise) all of which when taken together shall constitute one agreement binding on all Parties, notwithstanding that all Parties are not signatories to the same counterpart. 

### Attachment 2

Special Provisions: State Highway Work (Applicable to work on or along the state highway.)

### A. GENERAL REQUIREMENTS AND RESTRICTIONS

- 1. <u>General</u>: Certified Agency agrees to comply with all federal, state, and local laws, rules, and regulations and shall obtain and comply with the provisions of all necessary permits, licenses, and approvals, including land use permits, building permits, and environmental clearances for the Project. Certified Agency shall ensure its developers, contractors, subcontractors, and consultants performing work on the Project comply with such requirements.
- 2. <u>Notification:</u> Certified Agency shall notify the ODOT District 2B Office when performing onsite work on or along the state highway as follows:
  - a. Planning: At least two (2) business days prior to performing planning or survey work.
    To provide the notification in this subsection a, Certified Agency shall complete and submit to <a href="D2Bup@odot.oregon.gov">D2Bup@odot.oregon.gov</a> the "Oregon Department of Transportation 48HR. Work Notice" form, attached hereto as Appendix A and incorporated into this Supplemental Project Authorization by reference. Include the Key Number and the Supplemental Project Authorization number for this Project in place of the permit number.
  - b. Lane Restrictions: At least thirty (30) calendar days prior to performing any type of work requiring lane restrictions.
    - To provide the notification in this subsection b, Certified Agency shall complete and submit the "Highway Restriction Notice Size and/or Weight Form 734-2357" through Oregon Trucking Online at: <a href="https://www.oregontruckingonline.com/cf/MCAD/pubMetaEntry/restriction/">https://www.oregontruckingonline.com/cf/MCAD/pubMetaEntry/restriction/</a>.
- 3. <u>Restrictions:</u> Certified Agency shall not perform any work on or along the state highway requiring lane restrictions as follows:
  - a. Between 5:00 a.m. and 9:00 p.m. for single lane closures and between 4:00 a.m. and 10:00 p.m. for multiple lane closures on the Interstate.
  - b. During inclement weather (snow, ice, heavy fog, high wind) or between noon on the day preceding a legal holiday or holiday weekend and midnight of the legal holiday.
  - c. Without providing required notice as described in Paragraph 2 above.

### **B. PERMITTING REQUIREMENTS**

1. Permission for Project Work: ODOT grants Certified Agency permission to conduct Project work within the state highway right of way as described in this Supplemental Project Authorization and in accordance with the limitations set forth in Section A above. The work shall be protected in accordance with the versions of the Manual on Uniform Traffic Control Devices for Streets and Highways (MUTCD), the Oregon Supplement to the Manual on Uniform Traffic Control Devices, and the Oregon Temporary Traffic Control Handbook that are in effect at the time the work is conducted. In addition, the Project may be subject to the requirements of the ODOT Mobility Procedures Manual and approval by the ODOT Mobility Advisory Committee prior to submittal of the Plans, Specifications, and Estimates (PS&E) documents.
