

## Appointed Boards and Commissions (ABCs) Recommendation

The Board of Property Tax Appeals, interviewed and staffed by the Clackamas County Clerk's Office, currently board member openings due to annual term expirations. Board members are recruited through the community as volunteers. Up to eight board members are allowed to staff two rotating boards of three members each, with extra board member positions allowed for when substitutions are required and to build board member experience. Board of Property Tax Appeals board member terms last from October 15, 2020 through June 30, 2021.

In August and September of 2020 recruitment took place by press release with the county website and Nextdoor Neighbor app through PGA. Recruitment closed September 24, 2020. Through this recruitment process, seven applications were received. Six applicants are being recommended for selection; one applicant did not return our calls to setup an interview. The six applicants are prior BoPTA board members which suits BoPTA well for its need for experienced board members.

The recommendations are as follows:


- Vicki Pounds – Recommended as a full time board member, 9 years of experience on BoPTA
- William Spencer – Recommended as a full time board member, 18 years of experience on BoPTA
- Darrel McCarthy – Recommended as a full time board member, 13 years of experience on BoPTA
- James Temple – Recommended as a full time board member, five years of experience on BoPTA
- Richard Deich – Recommended as an alternate board member, five years of experience on BoPTA
- James Stallcup – Recommended as a full time board member, four years of experience on BoPTA

The Board of County Commissioners could select other candidates or require further recruitment.
