

Appointed Boards and Commissions (ABCs) Notification

Clackamas Workforce Partnership (CWP) is notifying the Board of County Commissioners of changes to the CWP Board of Directors. **Twenty five** members are allowed and serve a maximum of three three-year terms. CWP currently has three board openings due to:

- end of term for a County employee who served as the economic development representative
- reapplication for a second term by a labor representative
- a mid-term resignation of another labor representative

Recruitment for these positions was not open to the public, as the positions were open only to representatives of organizations that have demonstrated experience and expertise in:

- governmental and economic and community development entities serving the local area, who is a representative of economic and community development entities; Workforce Innovation and Opportunity Act (WIOA Section 107(b)(2)(D)(i))
- labor organization recommended by the Oregon AFL-CIO's workforce labor liaison, under the Workforce Innovation and Opportunity Act (WIOA Section 107(b)(2)(B)(i)).
