Your voted ballot must be received in the Elections Office, 825 Portland Ave., Gladstone, OR, by 8:00 PM on election night to be counted. Post mark does not count. If you prefer, instead of mailing your ballot, you may take it to one of the Drop Site Locations listed on page 4 of this pamphlet. Drop boxes will be available at these locations from February 19 through 8 pm on Tuesday, March 9.

If a ballot was delivered to your residence for someone who should no longer be receiving ballots at your address, please write "RETURN" on the envelope and place it back in your mail box. If a ballot was sent to someone who is deceased, please write "DECEASED" on the envelope and place it back in your mailbox.

A calendar of election events for 1999 appears on page 3. Please keep this calendar so you will know when measures must be filed and when you may submit an argument supporting or opposing a measure which may appear on our ballot in Clackamas County in 1999.

BALLOT TITLE

MEASURE PROHIBITING ANNEXATIONS WITHOUT VOTER APPROVAL

QUESTION: Shall the City Charter be amended to require voter approval of all annexations except those mandated by state law?

SUMMARY: The City Charter currently permits the city council or other agency with legal power to modify city boundaries to approve certain annexations without an election, in accordance with state law. This measure would amend the city charter to prohibit all annexations (including delayed annexations), unless mandated by state law, without the approval of a majority vote by the City electors.

The City Elections Officer has determined that the initiative measure meets the single subject requirements of section 1(2)(d), Article IV of the Oregon Constitution.

EXPLANATORY STATEMENT

Charter Amendment Initiative Measure

The City of Rivergrove has received a petition to amend Section 3 of the Rivergrove Charter. Section 3 establishes provisions concerning the City's boundaries. One method by which the boundaries could be enlarged is through annexation. An annexation brings land outside the City within the City limits. That land becomes part of the City.

Oregon law provides a number of ways to annex property into a City. This measure will require that before any land is annexed into the City of Rivergrove, an election will be held and the City electors will decide in each case whether the City should allow land to be annexed into the City. The only exception would be if the annexation is required by state law.

Approval of this measure would require majority approval of all annexation requests except those mandated by state law.

BALLOT TITLE

ELIMINATE MOLALLA RIVER SCHOOL DISTRICT ATTENDANCE AREA LOCAL SCHOOL COMMITTEES

QUESTION: Shall Molalla River School District eliminate elected attendance area local school committees and their election costs?

SUMMARY: Oregon law now requires all schools to form site councils which include parent representatives nominated and selected by that school's community. The legislature has given site councils broad responsibilities which supercedes the advisory role once performed by elected attendance area local school committees. This measure would eliminate elected local school committees only.

EXPLANATORY STATEMENT

1. In 1995 Oregon law changed to require schools to form site councils which include parent representatives elected at the site, along with school staff members. The formation of site councils has greatly reduced interest in the Local School Committee positions.

2. Because site councils have become the main decision making body in the school, Local School Committee members are playing a lesser role in school decisions. It has been difficult to find people interested in running for election to Local School Committee positions. In the 1997 election there were 14 vacancies and no filings for any of the positions. All vacancies were elected by write-in.

3. State statute requires a vote of the people to eliminate Local School Committees.

4. If this change is approved by voters, Local School Committees would be eliminated. Instead, the elected parent representatives from each school's site council will perform the Local School Committee's advisory role when meeting with the principal to provide advice and feedback.

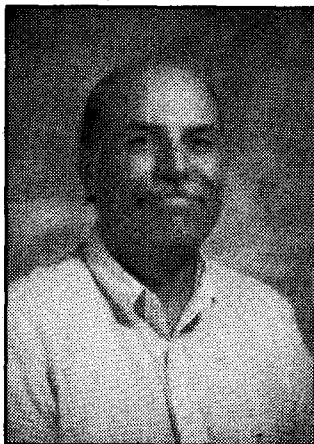
We need to give individual schools more freedom to experiment with different courses, methodologies, and technologies. We also need to make them more accountable to taxpayers by giving parents increased choices about where they can send their children. The likely passage of charter school legislation this year by the state legislature will give us an excellent opportunity to convert some or all of our existing schools to charters, and to encourage the creation of new charter schools. In such a system, the state allocation of student funding will follow the child to whatever public school is chosen by the family. This will give families more choices, and force schools to perform at a high level or risk losing students to superior schools elsewhere.

Regardless of what approach we try -- and the use of charter schools is just one option -- our schools need to change. I have the experience and skills to successfully lead the change process.
