EXECUTIVE SUMMARY: The Budget Committee for Enhanced Law Enforcement District met on May 22, 2023, and approved the Fiscal Year 2023-24 budget. The attached resolution adopts the budget of \$8,888,752 as approved and in accordance with Oregon Budget Law in ORS 294.

RECOMMENDATION: Staff recommends approval of the resolution to adopt the Enhanced Law Enforcement District’s budget, appropriate \$8,888,752 for Fiscal Year 2023-24, impose a tax rate of \$0.7198 per \$1,000 of assessed value on property within the district, and categorize the taxes as subject to General Government limitations.
