#### Overview

County Sustainability and Solid Waste staff introduced the County's efforts to launch work on a climate action plan at the June 4, 2020 C4 meeting, and solicited feedback on how best to engage cities in the process. Staff will be back at the March 4, 2021 meeting to update the group on project work to date, bring new C4 members up to speed, and answer questions.

In 2020, the Clackamas County Board of Commissioners identified action on climate change as a critical goal in their strategic plan, Performance Clackamas. The Board goal directs staff to complete a climate action plan that would identify actions and a timeline to become carbon neutral as a community by 2050. They also adopted 'carbon neutrality' as a policy perspective to weave throughout the County's work.

#### **Climate Action Plan Work**

The past year has presented multiple delays as staff has worked through the crises of COVID, wildfires, and the recent ice storm. Despite these setbacks, the project team has completed foundational work.

- Survey of city officials on preferred engagement options
- Hiring of a consultant team to develop the climate action plan
- Initial analysis of greenhouse gas emissions in the county
- Analysis of policies in the county, region and state relevant to climate action
- Soliciting applications for people to serve on a Community Advisory Task Force and a Youth Advisory Task Force






### **Decarbonization Phases**




### **Modelling Phases**





### Anatomy of the Emissions Reduction Pathway






Build as Planned 2050






### **Costs and Returns Modelling**




### Household Energy Costs Modelling







#### Summary:

Due to the large change in membership, staff will present a C4 Orientation that provides general information about the makeup of C4, common discussions and actions, and anticipated discussion topics.

Additionally, C4 selects its Executive Committee Members annually at the March meeting, according to the C4 Bylaws.

#### The current C4 Executive Committee includes:

- 1. County: Commissioner Paul Savas C4 Co-Chair
- 2. Rural City: Mayor Brian Hodson C4 Co-Chair
- 3. Urban City: Mayor Tammy Stempel
- 4. CPOs and Hamlets: Martin Meyers
- 5. Fire District: Matthew Silva
- 6. Sewer/water District: Paul Gornick

#### Process for selecting or reappointing new members

<u>*City Selection*</u>: The selection process for cities includes an opportunity for an urban city caucus to select an urban city representative and a rural city caucus to select a rural city representative for the Executive Committee. Because of changes to meeting formats due to COVID-19, this will occur via email in advance of the March 4 meeting.

<u>CPO and Hamlet Selection</u>: The bylaws are silent on how the Hamlet and CPO selection process occurs. Historically, the CPO and Hamlet (and Villages) caucus in advance of the meeting and notify C4 of their Executive Committee selection. An email has been sent to initiate that discussion.

<u>County and Special Districts</u>: These positions are self-appointed from the jurisdictions they represent.

#### **Required for March 4 meeting:**

Urban and Rural Cities should report their respective representatives for the Executive Committee.

#### **Overview:**

On February 9 the Board of County Commissioners asked county staff to schedule a policy session to discuss whether to continue the countywide Vehicle Registration Fee (VRF). That discussion is presently scheduled for Tues, March 2, from 1:30-2:30pm. Because cities receive 40% of the VRF revenue, and because C4 helps prioritize projects partially funded by the VRF through the Strategic Investment Fund (SIF), the executive committee agreed to make space on the March C4 agenda to discuss the outcomes of the BCC's March 2 meeting.
