Appointed Boards and Commissions (ABCs) Recommendation

The Economic Development Commission, staffed by the Business and Community Services, Economic Development Division, currently has 16 member openings due to term expirations. Up to 25 members are allowed on the Economic Development Commission with up to 3 year terms.

In January 2021, EDC member recruitment took place by press release, county website, and various other local media. Recruitment closed March 31st 2021. The recruitment yielded 12 applications; of those 12, four (4) were from past EDC members whose terms had expired on 12/31/2020. Of the other eight (8), three were selected based on being found to have qualifications that contribute to the diversity of business experience and background desired on the EDC. The remaining five (5) candidates were not selected due to their background being outside the areas identified by EDC leadership as those being needed to add broader business expertise and diversity to the EDC. To summarize, four (4) past EDC members are recommended for reappointment and three (3) new members are recommended for appointment to their first term.

The recommendation is as follows:

Michael Telford – appointment to 1st term; to end 12/30/2023 Carol Paulie – appointment to 1st term; to end 12/30/2023 Aeric Estep – appointment to 1st term; to end 12/30/2023 Vance Tong – appointment to 2nd term; to end 12/30/2023 John LaMotte – appointment to 2nd term; to end 12/30/2023 Laura Edmonds – appointment to 2nd term; to end 12/30/2023 Shannon Illas – appointment to 2nd term; to end 12/30/2023

The Board of County Commissioners could select other candidates or require further recruitment.
