EXECUTIVE SUMMARY: The purpose of this request is to approve the amendment allowing TS to extend CTERA Cloud Capacity and Services for an additional 1-year term. CTERA File Services integrates on-premises and cloud storage offering secure, cost-effective file access, sharing, and collaboration. County recently contracted with CTERA for cloud hosted file services earlier this year to improve disaster recovery capabilities. This request is to extend the term and expand the previous contract bringing the total contract value to \$175,044.49, over a 3YR term through SHI using cooperative Contract: Omnia Partners - IT Solutions, # 2018011-02. ARPA funds account for \$32,286.63 of the \$55,348.51 compensation change, and \$151,982.61 of the total contract value.

RECOMMENDATION: Staff respectfully recommends the Board of County Commissioners approve the Board Order allowing the amendment to extend the contract term for CTERA File Service.

Whereas, the Clackamas County Board of County Commissioners (the "Board") has authority to sign all contracts and any amendments or renewals of the same;

Whereas, Oregon Revised Statutes ("ORS") 279A.200-220 and Local Contact Review Board Rule C-046-0400 permit Clackamas County to purchase goods and services using cooperative contracts;

Whereas, Omnia Partners IT Solutions, a cooperative purchasing entity, established a cooperative contract, contract number 2018011-02, with SHI International Corp ("SHI") for the purchase of IT Solutions Products and Services;

Whereas, on or about May 2, 2024 the Clackamas County Department of Technology Services ("TS") purchased two years of Cloud Backup Services ("Software") for County emergency backup services by execution of a Clackamas County Purchase Order ("PO"), PO number 34572, in the amount \$119,695.68:

Whereas, TS requires the continued use of the Software for business needs and County data backup services. Such use requires purchasing additional years of services, the cost of which would exceed the authority of the original PO;

Whereas, TS desires to utilize the aforementioned cooperative contract with SHI to purchase licenses necessary to continue use of the Software, in an amount not to exceed \$54,969.04, for a total Software cost for both the prior PO and the instant purchase in an amount not to exceed \$175,044.19;

Whereas, TS requests authority to purchase the aforementioned Software by issuance of a PO; and

Whereas, a PO is issued directly through the Clackamas County Department of Finance's management software with no signature required or available;

NOW THEREFORE, the Clackamas County Board of County Commissioners orders as follows:

1. The requested purchase of the aforementioned Software from SHI, in the amount of \$54,969.04, is hereby approved; and

2. The Clackamas County Department of Finance is hereby delegated limited authority to issue PO to encumber the amount SHI invoices for the aforementioned software and services.
