WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

Staff requests the Board instruct staff to work with the regional partners to create a Complete Count Committee and to bring back a draft partnership resolution for Board consideration.

EXECUTIVE SUMMARY:

Background:

The US Constitution (Article 1, Section 2) mandates a headcount every 10 years of everyone residing in the 50 states, Puerto Rico, and the Island Areas of the United States. This includes all people of all ages, races, ethnic groups, citizens, and noncitizens. The first census was conducted in 1790 and every 10 years since.

The population totals from the census determine the number of seats each state has in the House of Representatives. States also use the totals to redraw their legislative and school districts. The next census occurs in 2020.

The U.S. Census Bureau must submit state population totals to the President of the United States by December 31, 2020.

The population totals also affect funding in our community, and data collected in the census helps us know how our community is changing. Approximately \$675 billion in federal funding is distributed to communities each year. Of that amount, Oregon receives approximately \$10 billion.

County Administration staff (Drenda Howatt) has been working collaboratively with staff from the U.S. Census Bureau, Multnomah County Commissioner Lori Stegmann's office, Washington County Administration office and the City of Portland to strategize and plan regional efforts to educate our communities about the importance of the 2020 Census.

Next Steps:

The Census Bureau is requesting that each County or region establish a Complete Count Committee to assist in identifying ways to reach hard to count communities.

As in the 2010 Census, there is also a request for each County to adopt a resolution to partner with the Census Bureau to encourage full participation in the Census. A list of promotional activities is in the process of being created to encourage participation; some of these activities may involve County officials or staff.

The census provides vital information for you and your community.


- It determines how many representatives each state gets in Congress and is used to redraw district boundaries. Redistricting counts are sent to the states by March 31, 2021.
- Communities rely on census statistics to plan for a variety of resident needs including new roads, schools, and emergency services.
- Businesses use census data to determine where to open places to shop.

Each year, the federal government distributes hundreds of billions of dollars to states and communities based on Census Bureau data.

In 2020, we will implement new technology to make it easier than ever to respond to the census. For the first time, you will be able to respond online, by phone, as well as by mail. We will use data that the public has already provided to reduce followup visits. And, we are building an accurate address list and automating our field operations—all while keeping your information confidential and safe.

Overview of Census Bureau Programs

CENSUSES

- The **decennial census** is the once-a-decade population and housing count of all 50 states, the District of Columbia, Puerto Rico, and the Island Areas. The results of the census determine the number of seats for each state in the U.S. House of Representatives and are used to draw congressional and state legislative districts. Federal agencies use the results to distribute more than \$675 billion in federal funds each year.
- The economic census measures the nation's economy every five years, providing vital statistics for virtually every industry and geographic area in the country.
- The **Census of Governments** provides comprehensive data about the 90,000 state and local governments in the nation every five years.

SURVEYS

- The American Community Survey (ACS) is an ongoing national survey—sampling approximately 3.5 million addresses annually—that provides vital information about our nation's housing and people. The ACS is the only source of comparable, quality information about the people in all our communities. These data show what the U.S. population looks like and how it is changing. ACS data are used to assess the past and present and to plan for the future.
- **Demographic surveys** measure income, poverty, education, health insurance coverage, housing quality, crime victimization, computer usage, and many other subjects.
- Economic surveys are conducted monthly, quarterly, and yearly. They cover selected sectors of the nation's economy and supplement the economic census with more-frequent information about the dynamic economy. These surveys yield more than 400 annual economic reports, including principal economic indicators.
- **Sponsored surveys** are demographic and economic surveys that we conduct for other government agencies. They include the Current Population Survey, the National Health Interview Survey, and the National Survey of College Graduates.

Census History

Thomas Jefferson directed the first decennial census in 1790. As required by the U.S. Constitution, a census has been taken every 10 years thereafter. In 1840, the Census Act authorized the establishment of a centralized Census Office. In 1902, the Census Office became a permanent organization within the Department of the Interior. A year later, it was renamed the Bureau of the Census and moved to the new Department of Commerce and Labor.

Notes and Findings:

- The <u>Counting for Dollars Project</u> will identify all federal financial assistance programs relying Decennial Census-derived data to guide the geographic distribution of funds.
- As an initial product, the project is publishing tables on the distribution, by state, of FY2015 funds from 16 large Census-guided programs.
- For every program but the National School Lunch Program, the equitable distribution of funds to a state depends on the accurate measurement of its population count and characteristics.
- There is not a straight linear relationship between state population count and federal funds flow. The per capita figure allows cross-state comparisons of fiscal reliance on census-guided programs. *It does not indicate the amount by which federal funding increases for each additional person counted*. (See The Leadership Conference Education Fund, <u>"Counting for Dollars: Why It Matters."</u>)

- Census-derived statistics federal datasets that are extensions of or otherwise rely on the Decennial Census (list available on <u>project website</u>)

2018 Census Test

The **2018 Census Test** is the culmination of more than a **decade of research** and the last major milestone before the **2020 Census**.

All systems deployed and integrated effectively.

Response Rate

52.3%

More than half of all households responded to the test on their own (surpassing our goal for the test).

Of those who responded on their own, **6 in every 10** did so **online**.*

Languages Tested

(These languages were tested for phone response. Additional languages totaling 12 non-English languages will be available for internet and phone response in the 2020 Census.) Those who did not respond to the mailed questionnaire on their own were visited by one of the **700+ census takers hired** for the 2018 Census Test.

The **test results showed** the Census Bureau was able to **successfully**:




- Automate processes for recruiting, hiring and training.
- Reduce workload by using administrative records to eliminate vacant housing units first.
- Optimize routing of field staff assignments.
- Capture and transmit interview data safely and securely.

APPROVAL OF THE 2010 CENSUS PARTNER PROCLAMATION

The US Census Bureau conducts a census of all households in the nation every 10 years; this data underlies most of our demographic studies and projections and is the basis for congressional districts and distribution of state and federal funds.

The Census Bureau has developed a Partnership program to work with local governments and organizations to assure a more complete count when the Census takes place in April of 2010. They have recently identified hard-to-count census tracts in Clackamas County, and have provided two Partnership Assistants to work in these areas to encourage full participation in the census. A list of census promotion activities has been identified to encourage participation in the Census; some of these activities would involve County officials or staff.

RECOMMENDATION

Staff respectfully recommends that the Board of County Commissioners approve the "2010 Census Partner Proclamation" in support of a more complete count in the 2010 Census.

- Create or seek opportunities to collaborate with other like-minded groups in our community, such as Complete Count Committees, to utilize high-profile, trusted voices to advocate on behalf of the 2010 Census.
