**EXECUTIVE SUMMARY**: Clackamas County Sheriff's Office desires to utilize the Sourcewell cooperative contract #101223-AXN and enter into a 3-year agreement with Axon Enterprise, Inc. to purchase Fleet 3 in-vehicle cameras, associated accessories, software services, cloud storage, installation, and related training for total of \$860,810.18 through June 2027.

**RECOMMENDATION:** Staff recommends that the Board of County Commissioners approve this Board Order delegating limited authority to the Clackamas County Finance Department to issue a Purchase Order with Axon Enterprise, Inc.

**Whereas**, the Clackamas County Sheriff's Office desires to utilize the aforementioned cooperative contract and enter into a 3-year agreement with Axon Enterprise, Inc. to purchase Fleet 3 in-vehicle cameras, associated accessories, software services, cloud storage, installation, and related training for total of \$860,810.18 through June 2027, as set forth in the Axon Enterprise Inc. quote attached hereto as Exhibit A and further described in the Cooperative Contract;
