### **I. CONSENT AGENDA**

#### **A. Elected Officials**

1. Approval of Previous Business Meeting Minutes – BCC

#### **B. County Counsel**

1. Approval of a Resolution adopting changed fees for Clackamas County for Fiscal Year 2023-2024. Fiscal impact is estimated at \$230,640 in additional revenues. No County General Funds are involved.

#### **C. Health, Housing, & Human Services**

1. Ratification of a Board Order delegating authority to the County Administrator to accept a non-competitive award from Oregon Housing & Community Services for mediation services for Manufactured, Marina & Floating Home Communities. Agreement value is up to \$400,000 for 2 years. Funding is through Oregon Housing and Community Services. No County General Funds are involved.

Budget is \$87,032,700, with appropriations totaling \$87,032,700. Funding is through rental incomes, Metro Bond Funds, Federal and State grants, and other revenue sources. No County General Funds are involved.

Budget Manager Sandra Montoya presented the budget resolution. No Commissioners had any questions or comments on the presentation.

Commissioner Paul Savas joined the meeting.

## V. PUBLIC HEARINGS

- A. Approval of a Supplemental Budget Resolution for a >10% adjustment for Fiscal Year 2022-2023. Fiscal impact is a net decrease in appropriations of \$904,632. Funding includes Beginning Fund Balance, Federal and State Grants, Charge for Services, Revenue from Bonds & Other Debts, and \$960,000 in budgeted County General Funds.

Finance Director Elizabeth Comfort presented the budget resolution. Commissioner Shull asked if this would be the last supplemental budget for the fiscal year. Director Comfort indicated it would be.

Chair Smith opened the hearing for public testimony. None was heard. Chair Smith closed the meeting for public testimony.

Chair Smith asked if the Commissioners had any further questions or discussion.

Commissioner Shull: "I move for approval of the Supplemental Budget Resolution for a greater than 10% adjustment for Fiscal Year 2022-2023." Commissioner Schrader seconded the motion.

- B. Approval of a Resolution adopting and appropriating funds for the Fiscal Year 2023-24 Budget, and Imposing and Categorizing a Property Tax for Tax Year 2023-24. Budget is \$1,266,733,717 with appropriations totaling \$1,144,331,087. Funding is through Beginning Fund Balance, Taxes, Federal and State Funds, Charges, Fees, Fines, and Assessments, Revenue from Bonds & Other Debts, and other revenues.

Budget Manager Sandra Montoya presented the budget resolution and outlined some technical changes made since the budget committee approval of the budget in May 2023, including a change to the General Fund Support for the Equity and Inclusion Office and the spending authorities created for the Clackamas Sheriff's Office in the inmate welfare and asset forfeiture funds.

Commissioner West asked about the Children of Incarcerated Parents program that was discussed at the budget committee meeting. County Administrator Gary Schmidt outlined that the program's funding is within major fund, and is not specifically called out because the budget does not include programmatic level spending details.

Commissioner West made comments about the concerns around the Equity and Inclusion Office and that he looks forward to a robust discussion with the Board on this topic, and that he supports the budget as proposed.

Commissioner Schrader asked the County Administrator for clarity around the Children of Incarcerated Parents program. County Administrator Schmidt explained that the program is being funded through ARPA, and would continue. Commissioner Schrader reiterated her support for the Equity and Inclusion Office from earlier meetings.

Commissioner Savas offered specific math on the Equity and Inclusion Office budget, general comments about the funding levels for public safety provided for in the budget, and support for the cost allocation models used in the budget.

Commissioner Shull made comments about his opposition to the Equity and Inclusion Office budget, but that he would support the budget today provided there is a robust discussion in the future about the functions of that office.

Chair Smith made general comments in support of the budget.

Commissioner Savas asked staff to clarify the budget of the Equity and Inclusion Office, which includes approximately \$3.6MM in ARPA dollars allocated to recovery efforts along with the standing budget for personnel and operations. Budget Manager Montoya outlined the current funding commitments in the budget.

Commissioner Schrader asked if staff could generate a list of the programs or non-profits being funded through those dollars. Staff indicated they would follow up. Further discussion around the reason that those dollars were parked in the Equity and Inclusion Office was provided by Chair Smith and Commissioner Savas.

Chair Smith opened the hearing for public testimony.

Elvis Clark (Milwaukie) – General comments about the budget

Commissioner Schrader made comments about John Mullin’s concerns and that she would be looking into them further. Administrator Schmidt indicated that work is underway to identify a new partner to take over the coordination staffing role that is being defunded, and that the County hopes to have news to share soon. Commissioner West made additional comments about the program.

Commissioner Savas expressed his concerns that the budget committee may not be receiving the same level of information as they once did with the abbreviated briefing format, and that he believes that more time should be spent going through the budget, department by department, to discuss changes and other recommendations.

Jeanette DeCastro (Unincorporated Clackamas County) – Opposed to cuts in the Equity and Inclusion Office

Jane Littlefield (Oregon City) – Opposed to cuts in the Equity and Inclusion Office

Chair Smith closed the meeting for public testimony.

Chair Smith outlined that the Board would be having an initial discussion on July 11 about the Equity and Inclusion Office to be followed by further discussions and public engagement.

Commissioner Savas made comments about the funding for the courthouse and that the legislature only authorized \$30M of the \$61M needed, and that if other funding can’t be found, the County may need to make additional cuts to fund the balance of the courthouse.

Commissioner West made general comments in support of the budget.

Commissioner Shull made general comments in support of the budget and asked staff to confirm that the tax rates are unchanged, which they did.

Chair Smith asked if the Commissioners had any further questions or discussion. None were heard.

Commissioner West: “I move for approval of the Resolution adopting a budget, with the changes from the budget committee approved budget as presented by staff, of \$1,266,733,717, and appropriating funds in the amount of \$1,144,331,087, for Fiscal Year 2023-24, and Imposing and Categorizing Property Taxes for Tax Year 2023-24 in the amount of 2 dollars and 40.42 cents per \$1,000 in assessed value for Clackamas County - City and 2 dollars and 97.66 cents per \$1,000 in assessed value for Clackamas County - Rural, a public safety local option levy tax rate of 36.8 cents per \$1,000 in assessed value, and \$5,559,000 for General Obligation bond debt service.” Commissioner Shull seconded the motion.
