## Appointed Boards and Commissions (ABCs) Recommendation

The Traffic Safety Commission, staffed by the Department of Transportation and Development, currently has seven openings on their commission due to term expirations and resignations. 10-12 members are allowed with four year terms.

Recruitment opened to the public on January 28, 2022 and closed on October 31, 2022. Recruitment took place by press release, Facebook, Nextdoor, and the county website. Through this recruitment process, seven new applications and three renewal applications were received and seven were recommended to be appointed.
