#### BACKGROUND

# Proposal No. 2023-006 is a proposed withdrawal of territory from the Canby Area Parks and Recreation District.

The Board approved a Preliminary Order to Withdraw Territory from the Canby Area Parks and Recreation District on March 23, 2023. Pursuant to ORS 198.810(2) a second public hearing is then scheduled to either approve the Final Order Withdrawing Territory from the Canby Area Parks and Recreation District or determine if one-hundred written requests for an election were received on the question of withdrawal of the territory. Notice of this hearing invited testimony from any interested party. Notice consisted of:

For Filing Use Only

1) Posting a notice at Canby City Hall, one notice in the Clackamas County Courthouse, and one notice near the County hearing room; 2) Notice posted online (<u>https://www.clackamas.us/meetings/bcc/business</u>); and 3) Published notice twice in the Clackamas County Review.

### PROCESS

If there have not been enough requests for an election received the Board will adopt a Final Order of Withdrawal and withdrawal becomes effective from that date. If enough requests for an election are received the Board will adopt an Order to Refer Question of Withdrawal of Territory to the next scheduled election not sooner than 90 days following the date the petition was filed.


Following an election the Board will either adopt a Final Order with Withdraw, or adopt an Order to Abate Preliminary Order of Withdrawal.

#### RECOMMENDATION

The Board should determine if 100 written requests for an election are received prior to or during the public hearing. If 100 requests are received, the Board shall adopt an Order to refer the question: "Shall the territory as described be withdrawn from the district?" be placed on the ballot in the next election suitable for this district matter.

If the Board determines that less than 100 written requests for an election are received prior to or during the public hearing. Then the Board shall adopt a Final Order Withdrawing Territory from the Canby Area Parks and Recreation District.

Based on the study and the public hearing the Board found:


- 1. Proposal No. 2023-006 is a petition for withdrawal of territory from the Canby Area Parks and Recreation District ("District").
- 2. The Board adopts the Final Order Approving the Withdrawal of Territory because 100 requests for an election have not been received.


#### CONCLUSIONS AND REASONS FOR DECISION


Based on the Findings, the Board determined:


- 1. The Board finds that CAPRD was formed in 1964 and during its existence does not have a permanent tax assessment and it is not supported by rates charged to users. CAPRD has not and is not providing parks and recreation services to the territory within its boundaries.
- 2. As a result of CAPRD's lack of funding, assets, and programs it is not feasible for CAPRD to provide parks and recreation services to the area to be withdrawn.



BEGINNING AT THE INTERSECTION OF THE LINE OF ORDINARY LOW WATER OF THE SOUTHERLY BANK OF THE WILLAMETTE RIVER WITH THE EASTERN BOUNDARY OF SECTION 27, TOWNSHIP 3 SOUTH, RANGE 01 EAST, WILLAMETTE PRINCIPAL MERIDIAN;

THENCE SOUTH ALONG THE EASTERN BOUNDARY OF SECTIONS 27 AND 34 OF TOWNSHIP 3 SOUTH, RANGE 01 EAST, WILLAMETTE PRINCIPAL MERIDIAN TO THE SOUTHEAST CORNER OF SECTION 34;

THENCE SOUTH ALONG THE WESTERN BOUNDARY OF THE EAST ONE-HALF OF SECTION 3, TOWNSHIP 4 SOUTH, RANGE 01 EAST TO THE SOUTH BOUNDARY OF SECTION 3;

THENCE WEST ALONG THE SOUTH BOUNDARY OF SECTION 3, TOWNSHIP 4 SOUTH, RANGE 01 EAST TO ITS INTERSECTION WITH THE LINE OF ORDINARY LOW WATER OF THE MOLALLA RIVER;




Based on the Findings, the Board determined:


