STEP 1:

How to request medical certification for protected leave

- Log into the patient account on the Kaiser website at KP.org
- Click on "Records"



• Click "Plan a medical leave of absence" to submit a new request for FMLA medical certification.

- Complete an online FMLA/PFML questionnaire through your kp.org account or through the Kaiser Permanente mobile app. You may also fill out a paper form, available on KP.org, and turn it into your medical provider.
- If you complete the online form through your kp.org account or the mobile app, it will automatically be routed for processing once it's submitted.
- Allow up to 10 days for the request to be processed. Your documentation may be completed sooner than 10 days, please keep checking for updates from your medical provider.
- Please note: Kaiser's release of information authorization may be required. Ask your medical provider if you are required to submit this document.

Submit protected leave medical certificate (FMLA form) to The Standard

- Upload or email the medical certification to:
 - Upload: <u>www.standard.com/absence</u>
 - Email: <u>absence@standard.com</u> Put your claim number in the subject line of the email to ensure the form goes to the correct claim.
 - Call The Standard to let them know you have uploaded the form.
 - o If possible, reference your Standard Claim Number in all your communications to the Standard.
