

# Most Market Values still decline for January 1, 2012



Real Market Value (RMV) on your tax statement is an estimate of the value your property would have sold for as of the January 1, 2012 assessment date. This value does not reflect continuing changes in the market after that date. Your Maximum Assessed Value (MAV) was established by constitutional amendment in 1997 (Measure 50) and, by law, grows 3% annually unless it exceeds the real market value. Property is taxed on the Assessed Value (AV), which is the lesser of real market value or the maximum assessed value. For most property owners, the maximum assessed value continues to be lower than market value so the 3% increase in assessed value results in an increase in taxes even though the market value may have **declined**. New construction, remodeling, or additions are exceptions to the 3% cap and may increase assessed value and taxes more than 3%.

# Oregon's Other Property Tax Limitation

Measure 5 (M-5) limits the amount of tax that can be imposed on a property to \$5 per 1,000 of real market value in the education category and \$10 per 1,000 in the general government category. Bonded debt is excluded from any limitation. As market values declined and assessed values continued to grow, savings to taxpayers from M-5 have grown and correspondingly schools and local governments received less revenue. The reduction in tax from exceeding M-5 limits is described as **compression**. Because the Measure 5 limits are tested on a property by property basis and are dependent on the difference between real market value and the assessed value as well as the tax rates, the amount of compression, if any, will vary between properties. Last year approximately 35% of all accounts had some savings resulting from the Measure 5 limits.

# Payment Due Dates

To receive a discount and avoid interest, **payments must be received**, postmarked, transmitted online or delivered by private express carrier **on or before Thursday, November 15, 2012.** Interest is charged on any unpaid portion of the first installment *after* November 15, 2012 at the rate of 16% annually. Payments made with electronic bill pay services must be received in our office by November 15<sup>th</sup> and need to be requested in advance. Payments returned for insufficient funds or postage will result in loss of discount.

Please include payment stubs with your check. **Discounts are lost if payments are not post marked or received by November 15, 2012.** Your cancelled check is your receipt. **Postdated checks are not timely payments.** All checks are processed as received. <u>Please do not mail cash.</u> Your payment by check authorizes us to process a one-time electronic funds transfer.



#### **Disabled Veteran Exemption**

A disabled veteran or surviving spouse of a veteran may be entitled to a partial exemption on their assessed value. To qualify, you must be certified by the US Department of Veterans Affairs as 40% or more disabled or a surviving spouse not remarried. A partial exemption also exists for active duty military personnel currently serving more than 178 consecutive days. This is an annual recognition of mediation services provided throughout the county and across the state. The governor's office has executed a similar proclamation, declaring November to be Mediation Month in Oregon. In addition, the Oregon Mediation Assocation is holding its 26th annual conference November 2 & 3 in Portland, Oregon, the Oregon Peacemakers Conference was held on October 18<sup>th</sup> which was also national Conflict Resolution Day, and the Restorative Justice Forum was held on June 28 and 29, 2012 in Clackamas County.

There are two County departments that provide mediation services to county residents. Resolution Services offers both family mediation services and community mediation services. All of these mediation services help empower our county citizens, encouraging them to utilize alternative conflict resolution services and learn effective skills that will help them deal more effectively with conflict in the future.

# Approval to Apply for a Continuation Grant for Oregon Department of Transportation Special Transportation Formula Funds through Ride Connection, Inc., for Services provided by Members of the Transportation Consortium of Clackamas County for <u>Clackamas County Seniors and People with Disabilities</u>

The Social Services Division of the Health, Housing, and Human Services Department requests approval to apply for a Continuation Grant for Oregon Department of Transportation Special Transportation Formula (STF) Funds through Ride Connection, Inc. for services provided by members of the Transportation Consortium of Clackamas County for area seniors and people with disabilities. This grant would fund the Clackamas County Transportation Consortium Out-of District programs in the amount of \$127,146 for basic transportation services for area seniors and persons with disabilities. The grant also funds the twelfth year continuation of expanded service for elderly and disabled transportation programs provided by some members of the Clackamas County Transportation Consortium of the amount of \$215,224.

The initial two-year grant for expanded service was approved by the BCC at the November 24, 1999 meeting and renewed annually thereafter. The grand total amount of the proposed renewal application will be up to \$342,370. The grant, if awarded, would have no effect on staffing. No County General Funds are involved.

The STF Funds will fund the Clackamas County Transportation Consortium for FY13/14 for the following services:

Out-of-District and Expanded Service transportation programs operated by Clackamas senior/community centers and the Transportation Reaching People program provide transportation services to seniors and persons with disabilities who live outside of the TriMet district or outside the centers regular service area. Rides are provided by senior center vans and volunteer drivers using their own vehicles. Rides are provided to nutrition sites, medical appointments, personal business and social activities. The specific centers and services included in this Special Transportation Formula Funds for transportation services are the following: Canby Adult Center, Estacada Community Center, NCPR-Milwaukie Center, Molalla Senior Center, Hoodland Senior Center, Pioneer Community Center, Sandy Senior and Community Center, and Transportation Reaching People. Funding is also provided to Social Services for administrative costs.

# Approval to apply for the Providence Health Plan/Kaiser Permanente Community Benefit Fund of Oregon Community Foundation Behavioral Health Services for Vulnerable Communities Grant Funding Opportunity

The Clackamas County Health Centers Division (CCHCD) of the Health, Housing and Human Services Department requests the approval to apply for Providence Health Plan/Kaiser Permanente Community Benefit Fund of Oregon Community Foundation (OCF) Behavioral Health Services for Vulnerable Communities Grant Funding Opportunity Request for Proposal (RFP).

This Request for Proposal (RFP) addresses the prevailing needs within the mental and behavioral health arena. It considers the Affordable Care Act and the broader movement towards a reformed behavioral health system. By funding innovative projects, OCF seeks to improve the mental health and well-being of our communities. If awarded, CCCHD will use the funding to implement a pilot program that integrates addiction, mental health and primary medical services in behavioral health treatment settings.

The potential grant award will average \$100,000 per year for up to three years. There is no match requirement and no County General Funds are involved. If awarded, CCHCD requests authority to establish 1.0 additional FTE to complete the project. Initial awards will be effective January 1, 2013.

#### Recommendation

We recommend the approval to submit this RFP response and further recommend that Cindy Becker be authorized to sign on behalf of the Board of County Commissioners.

#### SURFACE WATER, STORM DRAINAGE AND SANITARY SEWER EASEMENT CLACKAMAS COUNTY SERVICE DISTRICT NO. 1

KNOW ALL PERSONS BY THESE PRESENTS, that SA Group Properties, Inc., a Minnesota corporation, hereinafter referred to as the Grantors, for the consideration hereinafter stated, paid by Clackamas County Service District No.1, hereinafter referred to as the District and the mutual benefit hereby gained, which consideration and benefit are hereby acknowledged and receipted by the Grantor, do hereby grant, bargain, sell, and convey unto the District, a permanent easement and right to lay down, construct, reconstruct, replace, operate, inspect and perpetually maintain sewers, wastewater, storm drainage or surface water pipelines, and all related facilities through, under and along the following described property in the County of Clackamas and State of Oregon:

#### Tax Lot # 12E33AD01200

See Exhibit "A" for permanent easement legal description. See Exhibit "B" for exhibit map of permanent easement.

If a temporary construction easement is granted, the temporary right shall cease when the construction or improvement of said facilities, is completed.

It is understood and agreed that no building shall be erected upon said easement premises without the written consent of the District. Following construction the District will restore area to original grade and stabilize the surface. The District will restore, as near as practical, the landscaping that may exist or be placed within this easement disturbed by construction, maintenance, repair, or replacement. The public, through the District, shall give reasonable notice to the landowner before activities in connection with surface water, storm drainage, or sanitary sewer facility are commenced and shall limit activities to those necessary to achieve the purpose of constructing, reconstructing, enlarging, replacing, repairing, inspecting or maintaining the facility.
