RE: Performance Clackamas Business Friendly Environment Implementation Team update

Chair Smith, Commissioners and Administrator Schmidt,

On behalf of the Performance Clackamas Business Friendly Environment Implementation Team, in addition to the review form reflecting our work to date, we are pleased to submit a few highlights via this memo.

Goal: By 2024, 75% of businesses working in Clackamas County report a business-friendly environment that supports stability and growth.

Key Activities:

- Team established definition of Business Friendly Environment: A business friendly environment supports
 the business community in several ways: two water types (surface, and waste), transportation, and
 affordability of development, the regulatory environment (which cities have a major influence over), efficient
 and timely permit processing, housing, and a trained and capable workforce. Includes ability to expedite
 requests, etc.
- Formation and support of Business Recovery Centers in partnership with local Chambers of Commerce in response to COVID-19 over the past two years.
- Received BCC approval on 10/6/22 to move forward with a Business Survey to establish baseline data point.
 Purpose of this study is to develop a baseline estimate of the proportion of businesses working in Clackamas County that report a business-friendly environment in 2022, as well as to support business stability and growth.
 - o Financial contribution of \$5,000 from Water Environment Services to support the deployment of the business survey.
- Establishment of on-line permitting system (DTD)
- Assessment & Taxation department implemented an online process for businesses in Clackamas County to file their personal property tax returns online. Very few counties have this option, saving time and resources.

CBX, in partnership with local ISPs, received ARPA grant to install fiber to underserved areas in the County. Phase 1 has started with goal of reaching over 630 homes. Phase 2 is under evaluation.

• DTD is using virtual Happy or Not feedback mechanism and will be expanding the offering for use in all

divisions.

Clackamas County is temporarily waiving property tax interest charges on unpaid or late 2020-21 tax

payments for qualifying businesses.

Partner outreach and research:

Staff continues to identify and engage with subject matter experts moving forward as we complete our analysis and

identify key strategies.

Facilitated conversations with Economic Development Commission, Community Partners Roundtable (City, Chambers of Commerce, Business Recovery Center, and Main Street staff) to gather feedback on Business

Friendly Environment activities.

Future conversations to be facilitated with local business and industry associations such as the Clackamas

County Business Alliance and others.

Barriers and challenges:

While the team recognizes we are early on in the information gathering phase, below are a few barriers and

challenges identified to date:

• Feedback received from external partner on long lead times to develop and execute contracts. This could

be due to timing with COVID and staff capacity, but should be monitored.

• Identification of customer base. No central location of business contacts who request services for the

County.

Limited tools to influence the overall business environment.

Key Strategies

Research/define business-friendly environment

Definition: A business friendly environment supports the business community in several ways: two water types (surface, and waste), transportation, and affordability of development, the regulatory environment (which cities have a major influence over), efficient and timely permit processing, housing, and a trained and capable workforce. Includes ability to expedite requests, etc.

Clearly articulate what services the County provides for businesses

Survey the business community (focus on unincorporated parts of the County) with input from Economic Development Commission (EDC) and other key partners like Chambers of Commerce. Define businesses to be surveyed based on community input. Coordinate with PGA on survey options, can we include a question in annual all-county survey?

Process map how we are delivering services to businesses

Leverage assessments planned as part of the Sunrise Corridor Visioning and similar efforts (like East Happy Valley Comp Plan and Opportunity Zones)

Partner with Community-Based Organizations (CBOs) to provide programming and support for businesses

Encourage cross-departmental collaboration (like the Business Response Team)

Engage EDC and other subject matter experts to gain feedback on goal and strategies

Cross-collaboration with other MFR Implementation Teams, cross-walk key strategies

Coordinate with Clackamas County Disaster Management on tools for farmers around business resiliency

Explore potential of adding feedback link for customers to signature lines of staff email – immediate feedback on customer experience

Related Metrics

By 2026, 15% increase in jobs that meet the self-sufficiency standard wage in Clackamas County

By 2024, funding for the next Phase (from 122nd-172nd) of the Sunrise Gateway multimodal corridor improvements will be committed from federal, state, and/or regional funding sources.

By 2024, funding for the Interstate 205 (I-205) Widening and Seismic Improvements Project, including the Abernethy Bridge, will be committed from federal, state, and/or regional funding sources.

By 2023, the Climate Action plan is adopted for our community with specific recommendations to reach the goal of being carbon neutral by 2050.

By 2026, 10% increase in food production and food production acres from agricultural land in Clackamas County

By 2025, 1,500 affordable housing units will be developed. Those units will be stratified across the Area Median Income (AMI) ranges as shown in the BCC Goals.

By 2026, 100% of County residents and businesses – where served – have access to safe and affordable infrastructure: multimodal transportation including roads, sewer and broadband services

Activities Completed to Date

Refocused around the new goal language (previously focused on commercial land availability, which is just one component of business-friendly environments)

Connection made with EDC for initial feedback (7/28/21)

COVID response pushed the County to offer more services online (like *Development Direct* - DTD's 24-7 permitting platform)

Formation of Business Recovery Centers (through Chambers of Commerce)

Economic Development efforts like: Community Partners Round-table, Small Business Development Center (at Clackamas Community College), Micro Enterprise Services of Oregon's technical assistance for businesses, scholarship programs through Clackamas Community College

Developed draft definition of "Business Friendly Environment"

EcDev develop list of business contacts, include approx. number of members and site sectors, etc.

Developed scope of work for survey – partnered with Small Business Development Center

Facilitated discussion with Clackamas County Economic Development Commission

Facilitated discussion with Community Partners Roundtable (City partners, Main Street Managers, Business Recovery Center leads)

Development of Small Grants Program to support local businesses using Lottery Funds- in process
